Anna Gill, the youngest of nine children of GEorge and Hannah Gill, owned and operated photo studio on the south side of the Monroe Square from -1906 until 1916. She had started working there with F.M. Weigel in 1900, having demonstrated an interest for the arts, painting, sewing and embroidery. She was joined in the busi ness by her sister, Hannah, who was more proficient at writ ing and was four years older. Neither of the women married, and Hannah died Oct. 15, 1949, at the age

The two women left behind a legacy of glass negatives and photo albums which trace the early -day history of Monroe, but some of these were lost in subse quent fires. Helen Soper and her deceased husband, Bud, cared for "Aunt Annie" in her later years and Helen continues to be custodian of those photos that remain, along with the spinster's original camera.

Mrs. Sopner-kich ardson, the daughter of George and Olga -Bleiler, said George Gill was patriarch of the clan. He was born in England, and moved from the country into Monroe with his five children in 1883. Hannah was valedictorian of her high school class and graduated in 1887 from what was then a two-year term. The Gills sold their studio to a Mr Frautschy in 1916.
