#### September 23, 1898

**Ira Emerick** and **Belle Guinter** of Twin Grove were married at noon Sunday, Sept. 18 by Rev. J. A. Beidler. The bride is the daughter of **Mr. and Mrs. Guinter** and is highly spoken of while Mr. Emerick is too well known in this vicinity to need any comments from us.

**R. C. Whitcomb** has had his list of boarders increased here this week by the arrival of 18 patients from the Mendota hospital. Only two of them are Green County incurables, **Fred Mohns** and **John Brown**.

**Pte. Jesse Gleason**, a Monroe boy who enlisted in Company E, 1st Wisconsin Volunteers, died in the 2nd Division Hospital in Jacksonville, Florida yesterday afternoon after a long illness of typhoid fever.

#### September 30, 1898

**William Pratt**, a farmer near Monticello met his death last Monday morning at the crossing near the woolen mills at Monticello. As he drove up on the crossing, the south bound passenger train reached the crossing about the same time when the engine struck the team and wagon resulting in the death of one horse and breaking the hind legs of the other horse, smashing the wagon into kindling wood and killing all but two hogs of his load. Wm. Pratt was thrown some thirty feet breaking several of his ribs and inflicting other wounds on his body from which he died in a few

hours.

The sick soldier boys are all reported on the mend. Although some are doing a little better than others they all passed the critical point. **Major Stearns, Capt. West, Hospital Steward Darling, Sgt. Frank Shriner** and **Pte. Ned Shoefeld** and **William Lee** have been the sickest from the company since their arrival.

The remains of a two and a half year old son of **Mr. and Mrs. Christ Straus** of Racine were brought to this city Saturday evening for burial. The funeral took place Monday and was largely attended.

**G. T. Hodges** sends word from Jacksonville that **Corp. Wittwer, Corp. Becker** and **Pte. Kline** are ready to start for home and **Dr. Gungi** is on his way with **Corp. Isely. Pte Hodges** and some of the others will be able to make this trip home in about ten days. **Pte. Barrington** is very low.

**Miss Nellie M. Scott** of this city and Charles **Wattawa**, a promising young lawyer of Kewanee, Illinois were married Wednesday, Sept. 28 at the residence of the bride's sister **Mrs. Harry Austee**.

Married, Wednesday, Sept. 28 by Rev. J. H. Berkey, **Miss Anna Mary Bresle** of the township of Adams and **Edwin S. Ellis** of Jordan.

**Miss Sadie Clawson** of Brodhead will marry **Ossian T. Waite** of Oshkosh at noon Friday Oct. 7 at the residence of the bride's parents, **Mr. and Mrs. B. R. Clawson** at Brodhead. The groom is a graduate of the state university.

**Mrs. Maria Karlen** died Sunday afternoon at the residence of her son **Jacob Karlen, Sr.**, in this city, after several months illness from the infirmities of old age. Mrs. Karlen enjoyed the respect and love of a large circle of friends. She was a kind and loving mother, a good neighbor, ever ready and willing to assist and help when it was in her power. During the last year she had to suffer much and the angels of death came to her as a welcome deliverer from all earthly cares. She was 83 years of age. Four sons and many grandchildren survive her. The funeral took place yesterday afternoon from St. John's (German) Church.

The remains of **Private Jesse Gleason** of Company E, Beloit, who after a long and lingering illness of typhoid fever, died at Jacksonville, Florida, arrived in this city on Monday evening. The remains were taken to the residence of **Wm. Blount** where they remained over night. The funeral took place Tuesday afternoon at 1:30 from the house. The body was then taken to the cemetery and interred when the procession proceeded to the Presbyterian Church where the funeral sermon was preached. Jesse was a resident of this city and went to Milwaukee intending to join Company H but that company was full so he enlisted in Company E of Beloit where the body was shipped but as his parents, who are residents of Beloit, wanted the interment to take place here, the body was then sent here. He is the first soldier of the Spanish American War to rest in our beautiful cemetery.

**Mrs. Henry Stuessy** of New Glarus died last Friday. The funeral was held Monday and was largely attended.

A double wedding was celebrated at the residence of **Mrs. Elizabeth Roderick** Tuesday when her two daughters were married: **Elizabeth** to **Walter E. James** and **Nora** to **Joshua Zweifel**. The ceremonies were performed by Rev. Case. The brides wore beautifully trimmed traveling suits of broadcloth, one of green and one of blue. Each carried a bouquet of cream roses. Nearly 60 guests looked on and after the ceremony a wedding feast was served. The customary bride's table was in the dining room and around it the two brides and grooms sat with Mrs. Elizabeth Roderick, mother of the brides and **J. N. James** of Columbus, Wisconsin, father of W. E. James. After the wedding the couples intended leaving for Chicago on the 2:28 Illinois Central. The guests were eager to get away to prepare for the shower of rice and old shoes at the depot. The crowd was on its way to the depot and the hack that was to bring the couples later was off towards Juda in accord with secret plans that had been made to drive to Juda and leave on the train for Milwaukee. In consequence there was disappointment at the depot and few knew to what extent this was enjoyed by those in the hack but the tables overturned at Juda when a party of ten, well supplied with rice and old shoes and band boxes bearing various lettering were on the afternoon eastward train that left at 3:37 and which the occupants of the hack boarded to get to Milwaukee. The unexpected party was quickly in evidence and the delayed sent off was worse than might have been expected at home. The delegation went on as far as Brodhead and returned

The young man was formerly a foreman on the Illinois Central.

Monday night **Mrs. E. W. Norton**, occupying the rooms lately occupied by **Carl Ruf** as a cigar factory, was found lying on the floor where she had fallen from a stroke of paralysis. **J. C. Baker**, Poor Commissioner, was notified and had her taken to the county home to be cared for. Mrs. Norton is a colored lady who lately came here from Mineral Point and made her living by making switches, etc., of human hair.

#### October 14, 1898

**W. H. Davis**, a citizen of Dodgeville, was one of the few who struck it rich up in Alaska. He returned to his home from the Klondike this week.

**Guy Silver**, son of **Mrs. G. O. Stearns**, is now suffering as the result of the misfortune that robbed him of his eyesight two years ago. He has been attending the state school for the blind at Janesville and was sent home two weeks ago since which time he had been failing steadily. When he became blind, leading eye specialists who were consulted said that the ailment would eventually prove fatal and it is feared that their diagnosis of the case will come true. He does not eat anything and seldom recognizes his friends who call to see him. A general breaking down seems to have seized him.

**Frank Hayes**, a burglar who was caught in the act of entering a jewelry store in Albany was sentenced by Judge Bennett this afternoon to one year at Waupun. He was picked up one day during the fair by Marshall Blunt who suspected him of crookedness.

The last jury case and the most noted one of the term is the criminal case against **J. R. Stout** and **Caroline Wright** which was not called. They were arrested one day of the fair by Marshall Blunt and it is alleged they are pick pockets. **Samuel Vance**, one of the most widely known of the influential farmers of Green County died Tuesday night as a result of a stroke of paralysis he received Saturday. Two years ago he had a stroke which affected the left side but the second stroke was general and rendered him entirely helpless. Up to the time of the first stroke he was always strong and robust and his ordinary weight was 200 pounds and he was a man of wonderful physical endurance. He was well informed, jolly and good natured in proportion to his size and a residence of over half a century in the same locality. In farming, he was industrious and successful and his farm of nearly 300 acres was regarded as one of the best in the county. He was born in Lafayette County, Pa., on Feb. 21, 1816. On Feb. 16, 1841 he married the wife who preceded him to the land of rest 15 years ago. He was a pioneer in Green County coming here in 1845 locating in Jefferson

Township and later going to Sylvester where he since resided with his son **D. W. Vance** who lives on the old homestead. Mr. Vance was a member of the Juda Baptist Church. Five sons and one daughter are the children who survive him. They are **Mrs. Will Roderick** and **J. B. Vance** of Jefferson Township; **D. W. Vance** of Sylvester Township; **George D. Vance** of Norwich, Kansas; **J. J. Vance** of Sacramento, California; and **E. T. Vance** of this city. The funeral will be held tomorrow at 10:00 from the home and at 11:00 from the Juda Baptist Church.

**Mrs. Charles E. Varney** who has been paying her husband, **Chaplain Varney**, a visit at Jacksonville, Florida, arrived home last evening. **A. F. Glascott**, **G. T. Hodges**, **Will Glascott** and **James Hodges** left yesterday. **Private Krebs**, Company B, died last evening at Jacksonville of typhoid fever. Chaplain Varney is engaged in some commendable work there.

### October 21, 1898

**David Goodman** who came to Green County and entered land from the government many years ago, died suddenly at his home in Clarno Sunday afternoon at 3:30. He was taken with a sick spell and moved to his bed where he expired. The funeral was held Thursday morning at 10:00. He was 87 years old and was well known. He was a native

of Pennsylvania. He came here in early days and managed the farm where he died continuously since he got it from the government. He is survived by his second wife and four children. The late **Mrs. Charles Miller** of this city was a daughter. The other children are **Mrs. W. T. Garrett** of Cheyenne, **Miss Emma Goodman** of Denver, **Noah** of Barnard, Nebraska(?), and **Lincoln Goodman** of Dakota, Illinois.

**Mrs. Sarah Bridge** died Sunday morning at 6:00 at the home of her son-in-law **J. H. Williams** in the 2nd Ward as a result of a stroke of paralysis that she received last Wednesday evening. She was the widow of **Jeremiah Bridge** who died in 1867. They located in Twin Grove in 1859(?) where she continued to reside until a year ago when she moved to Monroe with Mr. Williams. She has lived with him since 1871 when he married her only daughter who survives her. A step-son, **J. C. Bridge**, lives in Brodhead. She was a member of the Christian Church at Twin Grove and the funeral was held from there Tuesday morning at 11:00.

**Mrs. Nancy Bridge** who makes her home with **Mrs. J. T. Bridge** is dangerously ill. She is suffering from erysipelas.

**Jacob Weder** is here from Juda and left for New York Wednesday. He intends going back to his native land, Switzerland.

Mrs. **W. A. Bolender**, 33, died at Orangeville Sunday night. She was the daughter of **J. F. Rockey (or Rookey?)** of Oneco, Illinois.

**Emil Schneider** and family take their departure for Vesper, Wisconsin where they intend to take up their home. He will manage the farm that **John Schertenleib** has there.

**Mrs. F. L. Chenowith** is spending a few days in Chicago. Her mother, **Mrs. Irwin**, joined her Wednesday to leave for her former home, Zanesville, Ohio. Mrs. Chenowith may decide to accompany her.

**L. A. Hodges** who is making a stay in the east, writes from New York that he has been on board the U.S. warships in the harbor there. He was on the Iowa and saw **Ensign Nate Twining** just previous to his departure for the Philippines. He writes he found him well.

**Louis Frankenberge** of Clarksville, Iowa was here last Friday to attend the funeral of an old friend, **Samuel Vance**. Both were pioneers of Green County. He is now 81. He is making his son, **Professor Bower Frankenberge** of the state university a visit and came here from Madison.

The funeral of **Mrs. Sarah W. Bridge** was held Tuesday from the home of **J. H. Williams** of this city being a short service at the house. The sermon was at the Christian Church at Spring Grove and the trip was made in the storm. Rev. J. H. Berley officiated both at the house and church.

**Mrs. Haage** is dangerously ill at the home of her mother **Mrs. S. N. Darling**. She is 78 years old which makes her recovery very doubtful.

**Lavinia Kreyden** of Jefferson Township was declared mentally incompetent. Her son **Charles** was appointed guardian.

### October 28, 1898

**Mrs. Louise Haage** died at 3:00 Saturday at the home of her daughter **Mrs. S. N. Darling**. She was nearly 78 years of age. She has been very feeble for many years and for the past few years has been failing rapidly. The illness that resulted in her death started Sunday and its fatal termination was at once feared. She was born at Whittenberg, Germany on Feb. 24, 1821. She married **Fred Haage** and they came to America with a family of small children. Mr. Haage fought for his country after coming to America and died three years ago of a disability he received while in the service. Their home was in Waukesha. Mrs. Haage came here from there last July to make her home with her

daughter Mrs. Darling. **Mrs. Emmet Herbrant**, another daughter, living at Waukesha, arrived here Tuesday and was with her mother when she died. There are two other children, **Mrs. Messerschmidt** of Brooklyn, S. D., and **Frederick** of Waukesha. Mrs. Haage was the grandmother of **Mrs. F. W. Zimmerman** and **Eddy Sery**. The funeral was held Monday afternoon from the home of Mr. and Mrs. S. N. Darling.

**Peltz Sacker**, an old and well known resident of this city, died Monday morning at 4:00 at his home in the 3rd Ward. Two weeks ago he had a stroke of light paralysis and since then has continued to fail rapidly. He was 83 years of age and came to America in 1859 from Germany. He came to Green County 24 years ago. Five years ago his wife died. Two sons survive: **John Sacker** of Warren and **Jacob Sacker** of this city. The deceased was a member of the German Lutheran Church all his life and was a good citizen. The funeral was held Tuesday at 1:30 from the house and at 2:00 from St. John's Evangelical Church.

**John Bundel** who was born in the town of Monroe March 12, 1845, died Saturday night at his home near the junction after a two year illness from tuberculosis of the larynx. He was 54 years of age and leaves a widow. The funeral was held Tuesday morning from St. John's Evangelical Church of this city.

### November 2, 1898

**Rev. Sweetland**, an old Episcopal minister who has been an inmate of the county farm for many years, died there Wednesday afternoon.

**Fred N. Whetstone**, a Beloit electrician, was instantly killed Wednesday by coming into contact with a live electrical wire while making repairs at the Fairbanks, Morse and Company's plant. Mr. Whetstone formerly resided at Janesville and was a son-in-law to **George A. Shurtleff**, the ice cream manufacturer. He was employed by the Beloit Electrical

Light Company coming there two months ago from Beaver Dam. He was employed by the Bower City Electric Light and Power Company of Janesville up to the time of his death. He was a thorough electrician. He leaves a wife and two daughters.

#### November 4, 1898

By kind dispensation of Providence five old ladies each of them past three score years and ten, met together with **Mrs. Calvin Payne** the other afternoon and recalled old times. Their meeting was in honor of Mrs. Payne's 72nd birthday which fell on Sunday, but did not prevent a surprise party that was arranged for her from taking place a day later. There were only five of them in all, **Mrs. E. R. Copeland**, **Mrs. Barbara Kadderly**, **Mrs. Clara McLean**, **Mrs. Phares Miller** and Mrs. Payne. They have been neighbors for over 30 years.

#### November 4, 1898

**Pte. James Farmer**, Company D, Darlington, and the last remaining 1st Wisconsin soldier at Camp Cuba Libre, Jacksonville, Florida, died Saturday night. When the hospital car that arrived at Milwaukee at Saturday noon last left Jacksonville, Farmer was too weak to be moved. **Chaplain Charles E. Varney** who accompanied the hospital car from Jacksonville to Milwaukee, arrived home Saturday evening. **Pte. During his life he made three trips to the old home in Germany. He first came to America in 1859 but he returned to Germany in June of the next year. At Frankfort on Sept. 29, 1863 he married **Katrinka Sentdorf**, the wife who survives him and in October of the same year they sailed for American where they remained until 1865 when they went back to Frankfort and remained four years. In the year 1869 after returning to America they located in Milwaukee and after a residence there of two years they came to Monroe where they have since resided. Mr. Einbeck was engaged in business in Mineral Point before he took up his permanent home in Monroe during the war time. Seven children, two girls and five boys, were born to Mr. and Mrs. Einbeck. Of these all are living except **Edward** the eldest son who died fifteen years ago. One son, the youngest, is in Texas and funeral arrangements will not be made until he has been heard from.
