### From the Albany Vindicator

#### **Albany Vindicator, January 5, 1893**

Died, at his residence in this village on Jan. 2, 1893, **Hiram D. Putnam**, aged 66 years, 7 months and 1 day. Hiram D. Putnam was born in Lancaster, Fairfield County, Ohio on May 31, 1826. At the age of 7 years he moved with his parents to Newark, Licking County, Ohio where he grew to manhood. In 1849 he came to Wisconsin with his parents where he engaged in teaching school winters and farming the remainder of the year. On December 18, 1856 he married **Sarah Connet** who was born in Licking County, Ohio. They settled on land he had previously bought on Section of the township of Decatur where he improved a large farm partly in Albany and partly in Decatur townships. In 1871 he came to Albany and purchased land which was within the city limits on which he built the fine brick residence which he occupied at the time of his death. He was one of the pioneers of this section coming here at an early day. By his labor and economy he had amassed a large competence and so used was he to work that he busied himself with the farm and garden until about three months ago when he was stricken with consumption of the stomach and bowels. It may truly be said that "he died in the harness". The funeral services were held at 10:00 today and the remains taken to the Dawson Cemetery on Jordan Prairie for interment

**Albany Vindicator, May 18, 1893**

**Mary St. John Williams** was born in the town of Mt. Pleasant on November 13, 1868. She was educated in the schools at Mt. Pleasant and Albany having attended Albany High School for several terms. Since this time she has been a successful teacher in the Green County schools. She was married in the summer of 1892 to **George Williams** and died on the 12<sup>th</sup> May leaving her husband and a babe of about three weeks to mourn the loss of a loving wife and mother. At the time of her death she was 24 years, 5 months and 29 days of age. The funeral was held at the M.E. Church Sunday and was largely attended.

**Albany Vindicator, June 15, 1893**

**William Henry Goodrich** was born at Windsor, Dane County, Wisconsin on December 2, 1863 and died at the home of his parents in this village on Wednesday, June 7 aged 29 years, 6 months and five days. Thus has passed away one of the noblest, purest young men to be found in our vicinity. He was a model young man, free from profanity, vulgarity and intemperance which characterizes the majority of our young men today. He was one of the few young men from whose lips an oath was never allowed to escape. While he was not a professed Christian during his long illness he gave evidence of a hope in Christianity both by verbal testimony and by a patient, uncomplaining resignation to the divine will. He wanted to live to comfort his parents in their old age but realizing that it was ordered otherwise, he yielded up his will, believing that death to him would be but a gateway to life and peace and joy. C. As stated last week, funeral services were held at the house Thursday afternoon conducted by Rev. J.C. Carter and the remains taken to the family burying ground in the town of his birth for interment.

During his last illness his

constant prayer was that he might be removed to that sweet rest in Heaven. The funeral was held at his late residence Friday conducted by Rev. H.A. Rogers and the remains interred in the Norwegian Cemetery.
