## **Albany Vindicator, Jan. 4, 1900**

Married, at the M.E. parsonage at Albany on Wednesday afternoon, Dec. 20, by Rev. H.B. Brenaman, **Alvin Francis and Vernie Trow**. Miss Vernie has been a teacher in the schools of Green County for several years, having been very successful teaching "Young America How To Shoot". Married, at the M.E. parsonage on Sunday morning, Dec. 31, **Albert C. Buss to Lizzie Falk**, Rev. H.B. Brenaman officiating. Mr. Buss is favorably and well known living in the Kelly neighborhood. Miss Falk lives in Sylvester where she is esteemed by all who know here.

Wedded, at the M.E. parsonage in Albany by Rev. H.B. Brenaman, Jan. 1, **Oliver Jones to Laura Bubb**. The ceremony was performed minutes after midnight on the threshold of the new year.

## **Albany Vindicator: Jan. 18, 2000**

**Harriett A. Case** was born on June 20, 1824 in the town of Windsor, Conn. She was married to **H.T. Bemis** on June 20, 1846 at Windsor, Connecticut. In 1862 they moved west to Wisconsin coming to Albany in the fall of 1866 where they have since made their home. She died on Jan. 2 at the home of her granddaughter **Mrs. Frank Webb** of Magnolia. She leaves a husband and one son, **E.H. Bemis** of California. Funeral services were held in the M.E. Church on Sunday, Jan. 14 at 2:00 the sermon was preached by Rev. H.B. Brenaman. A large pageant followed the broken alabaster box to its last resting place.

## **Albany Vindicator, Jan. 25, 1900**

**Miss Paula Paulson(?)**, whose death occurred at her home near this village, reminds us vividly of the sacred

truth: "Blessed are the dead that die in the Lord". Her death was calm and peaceful as a lovely sunset after a day of varied sunshine and shadows.

W. H. Bump died at his residence on the Eldred homestead on Monday morning, Jan. 22 from the effects of drinking carbolic acid. Whether it was done intentionally or not is not known as the attendants had left the room. Mr. Bump had been sick with typhoid fever for about a week. He leaves a wife and two children, one child by a former wife and a large circle of relatives to mourn their loss. **William Horace Bump** was born in Magnolia on Feb. 9, 1872. Most of his life was spent on the old homestead. For several years he was engaged in the livery business here and at Oregon. In his business dealings he had the confidence of those who dealt with him and being of a kindly disposition he had a large circle of friends. Funeral services were conducted by Rev. H.B. Brenaman at his late home yesterday. The remains were interred in the Magnolia Cemetery. The funeral services were largely attended.

### **Albany Vindicator, Feb. 22, 1900**

Passed to the spirit life from the home of her parents in this village Sunday morning, Feb. 18, **Eva Warren**, aged 29 years and 1 month. She had been a sufferer for six weeks and her departure was not wholly unexpected and yet when she did to it was a great shock. No matter how conscious we are that our friends cannot live yet when they go it gives us all a shock. Truly it can be said that no one in the community will be more missed than she nor was there ever one more acquainted with the people. Being in the post office with her father for six years gave her an opportunity to meet and know all and to all she ever had a pleasant smile and kind word. No one ever knew her to be impatient or say any one unkind word. No one has ever been employed in the post office who was more popular than she. She was ever busy and if she only had the physical strength to sustain her what a power she would have been. If she was sunshine to the people who can ever estimate what she was to her parents. She was their life especially her mother's who lived in her sunshine and their lives were so blended together that they were almost inseparable. To her sister and brothers she was light and inspiration. But from our physical presence she has gone. Her mind was ever open to the teachings, truth and she never was taught the cruel dogmas and superstitions that so many have impressed upon them. She was truly a child of nature, happy, free and sunny, an inspiration to all. The funeral services were held at the residence on Tuesday afternoon at 2:00 and were largely attended. But there is no building in the place that would have held all who would have like to attend for all loved Eva. The address was delivered by G. H. Brooks of Wheaton, Illinois a friend of the family for many years who is now speaking in Milwaukee for a spiritual society.

#### **Albany Vindicator, March 1, 1900**

Died, at 1:30 a.m. on Monday, Feb. 26, Albert Ray, **infant son of Mr. and Mrs. Thomas Hamer** of pneumonia. He was born on Feb. 26, 1899. The funeral service was held at the home of Mr. and Mrs. Hamer on the Bagley farm Tuesday, Feb. 27 at 1:30 pm. Quite a large number of relatives and friends gathered to extend their sympathies. The service was conducted by Rev. H.B. Gibbons and interment was in the Albany Cemetery.

Married on Feb. 22 at the residence of **Owen Atkinson, Martha Evans** of Attica to **Frank Zee** of Albany. Both are favorable and well known, the former is a teacher and the latter a tiller of the soil. The groom has rented the farm of William Bubb near Attica. Their pastor Rev. H.B. Brenaman spoke the words that joined their hearts and hands and destinies.

In alighting he struck a mile post and lay unconscious for several hours. About 3:00 a farmer, attracted by his cries, took him to a neighboring house where it was found that both legs were broken and he was otherwise terribly bruised. He became unconscious again Friday afternoon and remained in that condition until Saturday evening when he died.

She was sick only two weeks and was not considered to be seriously ill until the last few days. Mrs. Jordan will be greatly missed by all who knew her for she was a dear old lady, a Christian woman who at any time was willing to help others. She was a member of the M.E. Church of this place and was a good worker and proved very faithful. The funeral was held last Thursday and the remains interred in the Exeter in the East Dayton Cemetery. She leaves four children to mourn their loss.

Dayton: **Frank White** went to Chicago last week to attend the funeral of his brother **Fred** who was killed by a train.

### **Albany Vindicator, March 15, 1900**

**Parker Newman** of Juda and **Gertrude Berryman** of Monroe were married at Freeport on the 7<sup>th</sup> inst. The bride is the daughter of **Mr. and Mrs. A.L. Berryman** who lived just west of Albany for a number of years.

**Miss Effie Lindsay**, well known here, was married a few days since to **Frank Hill** of Mt. Pleasant.

**Miss Belle Cleveland** of McGregor, Iowa is here on a visit to her aunt **Miss J.C. Troutfetter**.

**Mrs. E. J. Hathaway** of Sioux City, Iowa is here on a visit to her brother **J.S. Smith**.

**Mrs. Anson Drefahl** of Cainville has been taken to Mendota's insane asylum.

**Mrs. Etta Francis** daughter of **Mr. and Mrs. J.P. Caradine**, secured a divorce from her husband **William Francis** on Friday last on the grounds of desertion. The couple had been married about a year but never lived together.

**John Zweifel** was acquitted of murder at Monroe on the charge of murdering **Jacob Babler**.

**Herman Lantzkw** died at his home in Sylvester Saturday evening. He was a volunteer in Company H going to Jacksonville with the last squad of recruits. He was buried at Juda Tuesday with military honors.

**Samuel Roderick** of Jordan Prairie is in a Chicago hospital where he had a surgical operation performed last week.

**Miss Maggie Rugg** leaves tomorrow for San Luis Obispo, California where she expects to make her home with her sister **Mrs. Albert Lymas**. The latter has lived in Nevada and California since 1868 or 1869. Mrs. Lymas has our sympathy in the death of her husband who passed from earth on the 2<sup>nd</sup> inst. Mrs. Lymas was a teacher in the first school this writer attended when a child.

### **Albany Vindicator, March 29, 1900**

**Martin Purinton**, who departed this life at his home in Mt. Pleasant, Green County, March 25, 1900, was born in Allegheny County, the town of Belfast, New York, on Sept. 8, 1827. He came to Waukesha in 1844 where he lived one year; after which he moved to Green County where he has ever since resided. He was married to **Marie L. Jewell** on Oct. 10, 1852. Seven children were born to them two dying in infancy. A wife and five children are left to mourn their loss of a loving husband and father. Two sisters and two brothers survive him. He experienced religion at the Mt. Pleasant Baptist Church in 1854 and has lived a consistent Christian life ever since. He served his country during the Civil War, enlisting in the spring of 1865 in Company I., W.V.I. and served until the close of the war. The funeral was held Tuesday, March 27. Quite a large number of relatives and neighbors and friends gathered at the home of the deceased from which place, after a song by a quartet from the Baptist choir of Albany, and prayer that followed, the body was taken to the Gap Church, arriving there at 2:30 pm. The funeral sermon was preached by Rev. H.B. Gibbons after which the friends were permitted to view the remains. The body was carried from the church to the cemetery by the bearers, all nephews of the deceased, where interment took place. The service at the grave was conducted by the Masonic fraternity which order the deceased had been a member for a number of years.

**Albany Vindicator, April 5, 1900**

**Mrs. Florence Phelps Lewis** died at her home in Milwaukee on March 26, aged 38 years. Death resulted from a stroke of paralysis. She was born in Galitan, Tennessee where her parents still reside. She was married to **Daniel Lewis** on May 7, 1894. She had been a resident of Milwaukee 32 years. Brief funeral services were held at her late home with kind and sympathetic friends following the remains to the depot. Funeral services were also held at the home of Mr. Lewis' brother **Silas Lewis** in Mt. Pleasant, words of comfort being spoken by Elder Graves of Albany. Her remains were laid to rest in the family cemetery at Exeter.

**Albany Vindicator, April 26, 1900**

**John B. Chase** was born in Erie County, Pennsylvania on Feb. 18, 1823. When 20 years of age he came to Wisconsin and entered the land and built the house which has been his home until his death which occurred on April 16. In November of 1852 he married Martha Baker Evans. To them were born five children, four sons and one daughter. One son died in infancy. Mr. Chase was a patient invalid for more than a year previous to his death but always had a cheerful welcome for his children and friends even to the last days of his life. The funeral was held at the home of the deceased on April 18 conducted by Rev. H.B. gibbons. Quite a number of relatives and friends followed the remains to the last resting place in the Evansville cemetery.

**William Winter Jones** was born in Brooklyn, Wisconsin on Feb. 28, 1865. He was married on Sept. 22, 1889 to **Etta Thornton**. He passed over to the silent shore of the unseen land on April 21. He leaves a wife and three children to mourn their loss, one child dying a few years ago. He had been ailing for years. The funeral was held Monday. The procession met at the home at 1:00 pm and conveyed the body to the Welsh Church where services were held after which the interment took place in the adjacent cemetery. The Masonic fraternity and the Modern Woodmen of America both took conspicuous parts in the services. Scripture was read by Rev. H.B. Brenaman, from the 1<sup>st</sup> Chapter of Revelations using a part of the 18<sup>th</sup> verse for a text, viz. "I am He that liveth and so died and behold I am alive for evermore."

From the Evening Times of Eagle Grove Iowa, April 13 we take the following: "At 1:00 am Friday at the home of her daughter Mrs. George Carlton, occurred the death of **Mrs. Caroline Goltry**, aged nearly 77 years. Mrs. Goltry's health has been very poor during the past winter until about a week ago when she was feeling so much improved that she walked out of doors for a short time. The exertion proved too much for her and her condition from that time grew steadily worse until the end. The immediate cause of death was heart failure. During the past 12 years Mrs. Goltry has been here at intervals with her daughter and for the past 2 ½ years has made this her home altogether. Among those who have known her, her memory will be long treasured. She was a very ambitious woman and a true Christian always ready to lend a helping hand to any who appeared to her for assistance. Hers was indeed a model life and one worthy of examination." The deceased was better known to the people of this vicinity as **Mrs. Vosburg** and lived for many years on what is still known as the Vosburg place southwest of Albany.

**Wayne Doolittle**, the 7 year old son of **C.E. Doolittle**, the jeweler at Brodhead, was drowned in the race just back of his parents home last Wednesday afternoon. The little fellow went fishing with several other small boys and

when they missed him they supposed he had gone home. The body was not recovered until 4:30 Tuesday morning, the water had been withdrawn from the race.

Word was received here Saturday noon of the death of **Mrs. Bert Annis** at North McGregor, Iowa but it was not possible for any of the relatives to go to the funeral which was held on Sunday. Mrs. Annis left a little son about four weeks old.

**C.L. Chase** of Burlington, Colorado is visiting at the home of his **mother Mrs. J.B. Chase**, having been called here by the death of his father. Mr. Chase went to Colorado 24 years ago and is now a prosperous rancher, owing large herds of cattle.

#### **Albany Vindicator, May 10, 1900**

Married, at the Baptist parsonage on May 9 at 3:30 pm **William E. Burt and Bertha L. Hornke**, both of Albany. Besides the contracting parties there were present **Frank Irwin** as groomsman and **Miss Vina Miller** as bridesmaid. The bride was very prettily attired in white silk with veil and orange blossoms. Miss Miller was also attired in white and made a dainty bridesmaid. The parties left for Brodhead by carriage.

From the Evansville Review: A marriage license has been issued to **Frank Nelms and Emma Layton** both of this city.

A very large funeral from this place occurred on Sunday, at 10:00 when Cecil(?) the beloved wife of **Burton Annis** was laid to rest. A very large concourse of sorrowing friends assembled at St. Mary's Church, McGregor, to pay their last respects to one who was so universally loved. Deceased was born on Jan. 22, 1877 at Waukon and died at her home in this city on Friday at 1:00 am, April 20. She was highly educated having received her education at the Sacred Heart School, Waukon, the convent at Lyons and the state normal school at Cedar Falls. She was graduated in the Class of '94 at the Waukon school. In April of 1894 she came with her parents to North McGregor where she has since resided and where she won many admiring friends. On Sept. 21, 1898 she married **Burton F. Annis**, a railway postal clerk and their short married life has been replete with choice blessings. Four weeks ago a little son came to their home and there cup of happiness was full. Only for a short time was the young wife to enjoy such earthly happiness when death, the silent reaper, gathered her to a higher fold and those who loved her so well watched the passing moments, each bringing them closer to a final parting. She realized that death was near and was conscious to the last with pleasant words for all and requesting them not to mourn. The funeral was held in St. Mary's Church and was very impressive and many were unable to gain admittance so large was the crowd. Rev. Father McGuire of Richland Center, Wisconsin preached an able sermon. She leaves to mourn her loss her husband and infant son, her parents and sisters **Margaret, Anna, Rose** and **Mrs. Dr. Stanton** and brothers **James** of this place and **John** at St. Paul, to whom we extend heartfelt sympathy. #### **Albany Vindicator, May 31, 1900**

Married, at the M.E. parsonage on Sunday, May 27, **Harry Culp and May Ethridge**, both residents of Albany. Mr. Culp is an employee in the Cigar Factory. Rev. H.B Brenaman performed the ceremony.

**Edward Lewis, brother of W.B. Lewis** and well known throughout the county, was killed about three miles west of Brodhead last Friday afternoon by a freight train backing down upon him. All efforts of the train men to attract

his attention were in vain and as they did not know he was deaf the train was not stopped. The entire train passed over him cutting off one arm and one leg and mangling him almost beyond recognition. He was identified by letters and he had over \$75 in his pocket. The remains were taken to Brodhead and relatives were notified. They drove down Friday night and brought him here for interment in the family lot at Exeter on Saturday morning. The deceased was 50 years old and had been deaf since a mere lad from an attack of scarlet fever. His face was familiar over a large territory as he was fond of traveling and was away from home a great deal. He had been visiting friends at Juda and was waking to Brodhead when the accident occurred. The wonder is that he was never hurt before but he was very susceptible to noise and it is thought he had discovered his danger in this instance but too late to save himself as he started to turn his head as the train struck him. Mr. Lewis' parents are dead but seven brothers and two sisters mourn his untimely death.

Married, at the home of **William Broughton** on June 6 by Rev. C.C. Swartz, **Jesse T. Gravenor to Jessie A. Broughton**, both of Albany. The ceremony was witnessed by a large number of friends of the couple. The bride was dressed in white silk and looked very pretty. The groom wore a full dress suit. They took the 4:00 train at Brodhead for Milwaukee. They will also visit Chicago during their bridal tour. Both Mr. and Mrs. Gravenor are well known and very much respected by everyone. The presents were numerous and useful. Among some choice presents from friends was a check for \$100 from the friends of the bride. C.C.S.
