# Albany Vindicator, Feb. 20, 1890

Died, at his home in the town of Sylvester on Monday, Feb. 17, **Erastus Hulburt**, aged 48 years, 8 months and 20 days. Brother Hulburt was born in North Manlius, New York and came to this state in March of 1859. He united with the Baptist Church at the age of 12 years and was a faithful member until his death. He had been in feeble health for a number of years but never in all these years has he neglected his Christian duty either at the family altar, the covenant meeting or church work. He has always been a member and regular attendant of the Monticello Prairie Church since his advent into the state and has worked faithfully in Sunday schools as superintendent or as a teacher in a Bible class. His constant plea has been even when many others were discouraged and even when the church was without an under shepherd that we must persevere in the Christian work. He leaves a wife and three children to mourn his loss, the youngest child being but 11 years old but he had the satisfaction of seeing them all in the fold of Christ. The funeral was held at the Gap Church on Tuesday, the service being conducted by Rev. J. Andereck of Juda assisted by the pastor of the M.E. Church at Albany and the remains interred in the adjoining cemetery.

**Josiah Williams** died at his home in Decatur on Sunday morning, Feb. 2 after an illness of only nine days with pneumonia. Mr. Williams was born in Columbus, Ohio on Nov. 27, 1826 and was consequently in his 64<sup>th</sup> year. He came to this state in 1847. He leaves a wife and five children besides a large circle of relatives and friends to mourn his loss. The funeral was held at the Dawson Church and his remains laid to rest in the adjoining cemetery. Rev. Woodruff, pastor of the M.E. Church at Brodhead, conducted the services.

Rosa Margarita Watkins, was born in Herefordshire, England on July 21, 1836 and came to America at the age of 16. In 1858 at the age of 21 she was married to **John L.** Morris of Brooklyn, Wisconsin. About the year 1860 they moved to Richland County, Wisconsin where they resided until December of 1883 when they removed to Evansville. She died at Evansville on Feb. 25, 1890 aged 53 years, 7 months and 5 days, leaving a husband and four children to mourn her loss. The service was held at the Union Church in the English Settlement on Feb. 27, Rev. J.F. Cowling officiating. Her last words were "Lord Jesus receive my spirit."

#### Albany Vindicator, March 13, 1890

**Alex Murrey,** whose death occurred on March 1, after a sickness of six months, was born in Erie County, New York on Feb. 24, 1818. In 1832 he removed to Michigan and located in Hillsdale County. Here he married **Laura Wright** of the same county where he lived. Three children were born to them in their Michigan home. The deceased came to Wisconsin in 1846 and secured a farm about half a mile between Brodhead and Albany which was his home for a number of years. Here seven other children were born to them. His wife died in 1862 on the 17<sup>th</sup> of February. In 1878 he was married to the wife who now survives him. In September, 1887 he left the labors of the farm and came to Brodhead for a home. The summer of 1888 they bought a comfortable home where they

had since resided. The deceased was a member of the Grange for about 16 years, most of the time holding an important position in the order. He was held in high esteem by his neighbors and entrusted by them with some of the important positions in the administration of the town. About 1854 he made a profession of religion and with his wife joined the United Brethren Church. In his last sickness, returning faith in Good took the place of doubts and questioning which had found a place in his heart. After log suffering he quietly passed away surrounded by his loved ones. Of the ten children, seven are still living and these all came from their homes to be present at the burial. This was held in the Baptist Church, the choir singing some of the old hymns which the deceased had loved. His remains were laid away under the snow but we believe he has gone to be with the Divine Father. Brodhead Independent
