He emigrated to Wisconsin with his parents in 1847 residing at the home near the Gap Church until the year 1861 when he responded to his country's call and enlisted in the 8th Wisconsin Infantry. In 1862 he received the appointment of Fife Major which position he held until the close of the war. After receiving his discharge he remained in the south until 1869 when he returned to the old home. He died on Sunday, Jan. 24 at the age of 49 years, 8 months and 24 days. A brief service was held at the residence of Robert Stephenson on Tuesday conducted by Rev. J.C. Carter after which the remains were conveyed to the Gap Cemetery and laid to rest.

J.F. Eggleston, one of the oldest settlers of Green County but a resident of Ansley, Nebraska since the spring of 1888 died at Ansley on April 7, 1892 at the age of 93 years. His wife and two children survive him, one daughter

being the wife of **J.P. Caradine** of Albany. The following sketch was taken from the Green County history: "J.F. Eggleston was born in Oxfordshire, England on June 2, 1799. He emigrated to the U.S. in 1821 arriving at Milwaukee. He was a stone mason by trade and worked on the capitol for a time but not liking the wild cat money with which he was paid left there and returned to Milwaukee where he worked on the light house for a short time. He and his brother then erected a light house at Racine. He then returned to Waukesha County where he and his brother had each taken a claim of 160 acres of land. He worked there at his trade during which time he took a contract to build a school house which was the first erected in the town. He was soon after appointed to the county board to open up a road from Rock County to Exeter. He served as road supervisor for two years and took his pay in county orders. In 1844 he removed to the farm he now owns. He was married to **Jane Gomm** in June of 1820. She died Feb. 19, 1857 leaving eight children, five of whom have since died. He was married to **Alice Brombert** on Oct. 18, 1850."

Albany Vindicator, May 26, 1892

Died, at his home in the town of Brooklyn, a few miles east of Dayton, on May 15, **Hon. C.D.W. Leonard**, aged 72, of lock jaw. The deceased was born in the state of New York in 1818 and came to Wisconsin in 1848 locating in the town of Brooklyn. In the early days he was quite prominent in political circles and represented his district in the assembly from 1869-70. He was engaged in the mercantile business for some years in Dayton and later at Attica. He has always taken a lively interest in public affairs and enjoyed to a high degree the confidence and friendship of his neighbors and those who knew him. The funeral took place to Dayton and was attended by a large number of friends.

Died, at his home near Dayton on May 15, C.D.W. Leonard, aged 74 years, one month. **Calvin Dewitt Leonard** was born in Hamilton, Madison County, New York on April 15, 1818 in which vicinity he spent his boyhood and received a good education at Hamilton College. In 1842 he emigrated to Ohio and in 1847 married **Margaret Wedrig** of Ohio and removed to Green County, Wisconsin where he ever after lived and died. The union was blessed with four children, three daughters—**Mrs. L.A. Simmons** of Manson, Iowa; **Mrs. M.N. Wood** of Rockton, Illinois; **Mrs. J.W. Campbell** of Ft. Dodge, Iowa—and one son **Charles** who lives on the old homestead. Mrs. Leonard, a brilliant, energetic woman, died on April 23, 1865. A few years later Mr. Leonard was married to **Mrs. Mary Ann Wood**, an amiable lady of Jamestown, New York who survives him. To them was born a daughter, **Mrs. E. A. Greenwood** of Beloit. Mr. Leonard purchased the farm on which he died 45 years ago. He was a merchant in Dayton and also for several years in Attica; was twice a member of the General Assembly of Wisconsin and could have secured a re-election several times had he so desired but he cared little for such honors preferring the quiet of home life. In his death the community loses a most exemplary character; the bereaved wife a kind and affectionate husband and father whose life in politics and social circles was above reproach. He was also one of those grand, pure and noble men that to be associated with makes a person feel that life is worth living. He possessed a happy, cheerful disposition which radiated beams of sunshine into the hearts of all with whom he came into contact. To become acquainted with him was to respect him; to converse with him was to go away wiser and happier. Full of years and honors he has suddenly passed into the night of day. J.W.C.

Carver** was born in Albany on May 3, 1866 and the large part of her life was spent in this vicinity where she has made many friends and no enemies. In early life she became converted and in 1887 united with the Baptist Church of Albany of which she has been an active and faithful member. On January 1, 1891 she was married to **John B. Francis** of Albany who with an infant child three weeks old are left to mourn the loss of such as can come but once in a lifetime. Her last illness was borne with patience and resignation and though life is sweet to one so young hear beautiful Christian faith and character enabled her to say "I am ready to go if it is the Lord's wish". Arrangements were calmly made by her for the disposition of her effects and even the text of her funeral sermon was selected by her. She expressed her love of her young friends and her advice was that all might so live that they would meet her in Heaven. The funeral was held at the Baptist Church on Monday, her pastor Rev. J.C. Carter conducted the service assisted by Revs. Rogers and Graves and was one of the largest ever held here many friends from a distance being present. Died, at Whitewater on Wednesday, Sept. 14, **Marvin Broughton**, eldest son of **Mr. and Mrs. Albert Broughton** of Albany aged 22 years and 2 days. Deceased had returned to school less than three weeks previous to this death. He had subsequently attended two terms of school there and by his genial ways and gentlemanly deportment both in school and in athletics won many friends. We copy the following from the Whitewater Register on Sept. 15, an account of his illness and death: "In our Normal items will be found mention of Marvin Broughton's death. An experience of this kind is new to the school and the deepest sadness prevails throughout every department and has aroused the earnest sympathy of all the Whitewater people. Marvin was one of the most popular students in the school; he occupied a high rank in his class, was generous, kindly and trustworthy and in all athletic games and sports he was always the leader. Last Friday he played a game of football with his usual energy and on Saturday he worked hard cutting corn. That night he ate heartily and soon after was taken with vomiting which continued through the night. His medical attendants suspected an obstruction of the bowels but were unable to afford any relief. As the case became critical Mr. and Mrs. Albert Broughton, his parents, were sent for and came from Albany. Yesterday morning Dr. H. Palmer came from Janesville and performed an operation assisted by Dr. Carey. It was found that the small and large intestines were telescoped eight inches and had adhered together. The necessary reduction was performed but the surrounding parts showed such inflammation and gangrenous condition that very little hope was entertained for his recovery and the final end speedily followed. A brief service was held at the house this morning, conducted by Rev. E.C. Barnard and the remains taken to Albany on the 8:45 train the faculty and students going to the station in a body." The funeral was held at the M.E. Church in this village and conducted by Rev. W.W. Stevens of Evansville. Marvin was born in Albany on Sept. 12, 1870, growing to manhood's estate in this vicinity, being of a genial disposition he made friends of all who knew him. As a member of the Grange, Patrons of Industry and Good Templars he had been an active worker, holding several offices of honor.

He received a sunstroke during the first Battle of Bull Run and an honorable discharge on Aug. 1, 1861. He was

married to **Rose A. Tuttle** on Dec. 9, 1862 in Concord, New Hampshire and for thirty years they walked the journey of life together, sharing each others joys and sorrows and bearing each others burdens. He was a kind and loving father, esteemed by all who knew him. He leaves a wife and two children, **Gertrude and George**, to mourn their loss. The funeral was conducted by Rev. J.E. Liddle of Monticello on Sunday, Sept. 11.

Edwin M. Peebles was born in Chautauqua County, New York on April 14, 1834. He died October 24, 1892 at his home in Albany aged 58 years, 6 months and 10 days. He moved with his father's family to Michigan in 1843, from there to Illinois in 1845 and to Wisconsin in 1846 where he has since resided.
