Died, at his home in Mt. Pleasant on Sunday, Jan. 30, **William Hillis**, aged 83 years, 9 months and 16 days. Funeral services were held at the Gap Church on Tuesday conducted by Rev. P.S. Rogers of this city. Mr. Hillis was born in Truxton, New York. When about four years of age his parents moved to Manilus, New York where he grew to manhood. He was married to **Elizabeth Phillips** on March 13, 1844 and came to Wisconsin in 1845 where they have since resided. The faithful wife and seven children survive him, two children having preceded him to the better land. Deceased became a member of the Adventist Church in 1855 and died in that faith.

Albany Vindicator, April 14, 1898

After a long and painful illness, **Mrs. William Fenton** died early Tuesday morning. Mrs. Fenton was the daughter of the late **Anson Smith** who lived in Albany for a number of years and was born and raised in Exeter. She leaves a husband and three children, Polly, Ida and Thomas, to mourn their loss. Funeral services were held at her late residence today and the remains interred in the Exeter Cemetery. Dr. Flower of Monticello and Drs. Morgan of this city held an autopsy on the remains and found a cancerous condition of the of the pancreas and duodenum which was the cause of her death.

Monroe, Wisconsin, April 11—**Michael Judd and wife**, an aged couple of this city, perished in the flames that burned their home at 10:00 last night. The house was beyond the reach of the waterworks and nothing could be done but to let it burn. One body was discovered burning upon a bed of fire while the skull of another protruded

through a bank of glowing coals after the house was destroyed. The trunks were taken from the debris today. Water that had been thrown upon the debris crumbled the skulls and started the report that they had been murdered. A coroner's jury was summoned to investigate the matter. Judd was a veteran of the late war. His wife was blind, deaf and bed ridden.

Mary Catharine Chamberlain, was born in Vienna, Trumbull County, Ohio on May 19, 1838 and died at Albany, on May 16 at the age of 60. She came to Wisconsin with her parents in 1845. They lived in the town of Monroe two years and then spent a year in Walworth County and a year in Rock County, returning to Green County and settling in Mt. Pleasant. She was married to **Samuel Truax** on Nov. 28, 1888. Mr. Truax died on Feb. 14, 1889. On the 2nd August, 1891 she married **L.W. Brigg** who survives here. Mrs. Brigg has lived an exemplary Christian life. She was of a retiring nature and possessed of the gift of making many friends and enjoyed the respect and esteem of all who knew her. The funeral was held at the M.E. Church Tuesday afternoon by Rev. N.J. Davis of Evansville.

Saturday, May 14 a large gathering of relatives and friends gathered at the residence of **Mr. and Mrs. V.D. Burt** to celebrate their Golden Wedding. Owing to the inclement weather all who were invited could not attend. 63 were present. After spending several hours in social conversation, playing games, listening to music, etc., rendered by **Mrs. F.N. His team of horses was also killed. He had been to Monticello and was about one mile from his home when the accident occurred. He was about 50 years old and leaves a wife and four children.

Jeremiah Brewer died at his home southeast of Albany last Sunday at the advanced age of 96 years, and 18 days. The deceased was born at Franklin County, Vermont.
