This community was startled and shocked last Monday to learn of the sudden death of **W.C. Van Ness** which occurred early that morning from heart trouble. He had been a sufferer from that disease for some time but his sudden demise was unexpected at least to most of his friends. **William C. Van Ness** was born in Pompton Plains, N.J. on July 5, 1846 and died at his home in Albany on Jan. 14 being 59 years six months and 9 days of age. As a young man, he was apprenticed as a mason later becoming a department manager in a large wholesale house. For 20 years following he was a traveling salesman until joining forces with others to engage in the manufacturing business. In September, 1904 he removed from St. Paul to Albany to assume control of the local Linen Mills having charge of the billing department of all the factories owned by the corporation of which he was a member and director. He was married in Newark, New Jersey at the age of 30 to **Emma A. Drake** with whom for 30 years he lived happily until death beckoned him away. While still a young man he united with the Baptist Church in Newark from which he never transferred his membership. During his short residence he won the good will and esteem of all. He was an intelligent, upright and honest man, industrious beyond his strength, gentle and kind in demeanor and domestic in habits, finding his chief pleasure in his own fireside. He leaves two brothers—**John** of Newark, New Jersey and **Josiah** of Boondon, New York together with the grief stricken widow. The funeral was held from the Baptist Church yesterday afternoon, Rev. C.A. Ehrhardt officiating, assisted by Rev. Peter Black. There were several handsome floral pieces one of which was presented by the employees of the mills. The pall bearers were also mill employees. Interment was in the Albany cemetery.

Mr. and Mrs. John Moar and daughter Flossie attended the funeral of Mrs. Moar's father, **Jacob Newcomer** in Brodhead on Friday. Deceased was a long time resident of Brodhead, highly respected and a veteran of the Civil War.

John Williams, a leading Janesville attorney and former representative of the 1st District in Congress, died at his home in Janesville Thursday night, aged 76. He was a Democrat and represented the 1st Wisconsin District in the 48th Congress from 1883 -1885, succeeding **Charles G. Williams** who had five successive terms.

William J. Hahn of Albany was charged with selling liquor without a license in a warrant that was issued by Justice Thomas Luchsinger this afternoon. Sheriff M.C. Durst and Deputy Sheriff H.L. Ball went to Albany to make the arrest. The warrant was issued on complaint made by Albany parties to the District Attorney W.H. McGrath. Hahn, it appears, has blossomed out into a hotel landlord and conducts the Central House. The hotel has come to be commonly known as a "booze" joint and has acquired some notoriety of late through a case that has been brought against a man by the name of **Kittelson by Charles Strunk**, who is associated with Hahn in the hotel business, to collect a hotel bill at the rate of \$5 per day. For "board, care and nursing" during a period that Kittelson was drunk in the house. Kittelson proved to be a liberal spender and succeeded in separating himself from a considerable roll while he was at the hotel and he claims that he did not know what became of his money.

The board bill case has not yet come to trial but the true character of the place has become known and the residents of the village have determined to make a fight against it. Hahn, for years, has persisted in selling liquor at Albany after the saloons have been voted out and has already figured in a number of cases in the circuit court. *Monroe Evening Times*, Jan. 17

Schindler** of Monroe besides a brother and two sisters in Germany. Mr. Hein was always esteemed for his integrity and by industry and frugality he amassed a competency. His sorrowing family have the deepest sympathy of the entire community. The funeral was held in the Baptist Church Monday afternoon, services being conducted by Rev. Schibley of Evansville. The stores were closed during the services. Interment was at the Albany Cemetery.

Segelke, the young Monticello physician, who became addicted to morphine and was committed to the Mendota Hospital died Saturday night in Milwaukee, it is said, from an overdose of morphine. He was 27 years of age. His parents and a brother reside at Platteville. He became addicted to the habit a few years ago as a

result of an infection in his leg which gave him great pain. He was paroled from the Mendota hospital in November and returned to Monticello.

Benjamin Howe, brother of **Mrs. E.S. Fessendon** of Albany, died in Minneapolis on Jan. 24, aged 65 years. In his boyhood days he attended school in the Smiley house. His father, **Henry Howe**, who lived in that neighborhood, preached in that school house. His home was in Monroe, Wisconsin for many years before going to Minneapolis where he has lived for the past 15 years. He was a veteran of the Civil War where he sustained injury from which he never recovered. He belonged to one of the Masonic lodges of the city and for several years he filled an office that brought him into prominence and he made many friends. In compliance with his wishes, his body was taken to their lodge room on Sunday, 27th and a beautiful service conducted by the order and the pastor of the Portland Avenue Christian Church of which he was a member, after which it was placed in a vault in Lakewood Cemetery near his home. There were many beautiful floral offerings by the church and the G.A.R. post to which he belonged, the lodge, and other friends. He leaves a devoted wife, a son and daughter who live in Illinois and two brothers and two sisters and many other relatives and friends.

After a year's illness from kidney disease, **Patrick Monahan** passed away at his home in Albany on Wednesday morning, Feb. 6. He was 83 years and four days old. He was born in Galway County, Ireland on Feb. 2, 1824 and came to American in the month of August, 1849. He married **May Wallace** of Janesville on Feb. 14, 1858. Eight children were born to them. Two daughters, **Mary and Nellie**, are dead. A wife and six children are left to mourn their loss, two sons and four daughters: **James** of Rolla, N.D.; **Gilbert** of Albany; **Mrs. Maggie Ward**, **Mrs. Agnes Trunkhill** and **Misses Hannah and Kittie** of Albany. The funeral services were held in the Catholic church, Rev. Father Smith presiding, on Friday morning at 10:00 and interment was in the Dayton Catholic cemetery in Exeter township near his old home. He resided on a farm in Exeter township for 37 years. Eight years ago he sold his farm and moved his family to Albany where he has since resided. The pallbearers were **John Gorey, Richard Burns, John Tourdot, John Carroll, Hugh Eagen and John Whalen**.

Little **George J, infant son of Mr. and Mrs. J.J. Truax**, of Sylvester, died Friday evening, Feb. 8 of bronchial pneumonia, 7 weeks old. The funeral Sunday at the home was officiated over by Rev. Peter Black, after which the infant was interred at the Gap Cemetery.

The case against **W.J. Hahn** alleged the illegal sale of liquor and was called at Monroe last Thursday and after the taking of much testimony was adjourned for one week. There seems to be plenty of evidence against Hahn. According to G.W. Bartlett's records, Hahn, on one day, December 20 last, was shown to have purchased 15 pints of alcohol. As liquor is presumed to be sold only for medicinal purposes, Hahn must have been a very sick man on that day. **John Kittelson** testified to paying all the way from \$5 to \$50 for a drink. Other witnesses for the prosecution were **Frank Maylord, Charles Mathems, and John Shafer** who gave ample evidence of the purchase or sale of liquor by Hahn.

Christian Spangler was born in Clinton County, Pennsylvania on Nov. 21, 1826. He came with his parents to Green County in 1845. He was united in marriage to **Esther E. Doolittle** on Jan. 2, 1854 at the residence of the bride's parents. No children were born of this union. Mr. Spangler has resided near Albany for upwards of 50 years and was well known and respected as a neighbor. After a lingering illness, he passed away at the old homestead on Feb. 20 aged 81 years and 3 months. He leaves to mourn his loss a wife and one sister **Mrs. Sarah Davenport** of Brodhead. Rev. P. Black conducted the funeral services in the M.E. Church and the remains were interred in the village cemetery. His three score years and ten are ended, death has come to close the scene.

James T. Fulton, son of William T. and Sarah Fulton was born in Mercer County, Pa. on Aug. 19, 1844 and

was but an infant when his father and family moved to Wisconsin. He lived with his parents until 18 years old when with their consent he started life on his own account. The first year he worked in Wisconsin pineries then engaged as a sutler's clerk for J.S. Gold, sutler of the 15th veteran Reserve corps stationed at Chicago, Springfield and Cairo. He was not employed about one year and then went to Montana and engaged in mining two years and then came back to Wisconsin in 1867 and took charge of lead mining in Exeter for an Evansville company and the Sugar River Lead Mines on Section 35. A few months later the work was abandoned. In 1869 his father made a trip to California hoping to benefit his health. James accompanied him and they returned the same season. James T. then settled down to life in Exeter and married **Mathilda Hayden** on Feb. 26, 1871. Two children were born to this union, **William N. and Cora Idell**. In the spring of 1889 the family moved to Albany and have resided in our midst for 18 years. After a lingering illness, Mr. Fulton passed away on Feb. 19, aged 62 years and 6 months, leaving to mourn his departure his wife, son and daughter. Also, four brothers and two sisters. The end came as a great relief; freeing his spirit from the bondage of the flesh. In Mr. Fulton's death there comes to a close the life of one of our best known and most highly respected citizens. He was a loving brother, son and friend, a tender husband, a father kind and ever true. None knew him but to love him. He was a member of the Masonic and Woodmen orders. The members of the Monticello Union Lodge #155 F & A M came in goodly numbers to pay their last tribute of respect. Services were held in the Baptist Church conducted by Rev. Peter Black.

The prosecution of **William J. Hahn** came to an end before Justice Edward Ruegger this afternoon when the hearing of the matter was resumed. An attorney for Hahn was in conference with attorneys for the state during the forenoon make a proposition for the purpose of having the prosecution dropped which was agreed to by **Charles Morgan, Cliff Knapp and Josh Wood**, representing the Law and Order League. Hahn offered to close up the hotel, abide by the law and do nothing in the way of violating the existing laws. He has rented the hotel to **Henry Kingdon** who, it is alleged, has deserted a wife and 8 children and being objectionable to the league no effort will be made to conduct the house under his management. The state was not a party to the arrangement and with the understanding that Hahn is to live up to the original agreement. The prosecution was dropped for the present upon a plea of guilty by Hahn in the case. He was fined \$50 and costs. The testimony by the state has implicated other parties who will be closely walked and the league may strike in another direction. **Charles Strunk**, who has been associated with Hahn is one of the parties complained of and it was asserted that if he returns to Albany they will be prepared to deal with him. Thomas Pryce was born in Montgomeryshire, Wales on March 12, 1831 and passed away after much suffering at the old homestead east of Albany on March 1. When but a boy his parents, with nine children emigrated to America. Their voyage on the sea in the sailing vessel lasted seven weeks reaching their destination in August of 1845. They located at Burlington, Wisconsin but soon removed and settled on the old homestead which has ever since been their home. Only a few months after reaching this country, the mother died. One by one, they preceded

him until but three of the family are left: **Mrs. Bartlett** of Attica, **Evan Pryce** of Boulder, Colorado and **Richard Pryce** of Thayer, Nebraska. At the age of 26, on March 29, 1857, he married **Sarah Nichols** with whom, hand in hand, he journeyed through life until within four weeks of their Golden Wedding anniversary. Their present house stands on the original site of their old cabin. More than thirty years ago he united with the Baptist Church in what was known as the English Settlement. The aged widow, three children, **Thomas** of Waseca, Minnesota; **Lettie** of Clear Lake, Iowa; and **Miss Addie** of Albany together with a large number of relatives and friends, mourn his passing. Funeral services were held at the home Sunday afternoon and interment was in the Albany cemetery. Rev. C.A. Ehrhardt conducted the services.

Franklin J. Burt was born in Chautauqua County, New York on Oct. 5, 1826. He came with his parents to Johnstown Center, Rock County, in 1845. After a residence of two years they moved to a farm in Decatur where for 60 years he has toiled as an industrious and successful farmer. He married **Emily A. Turman** on March 17, 1850. His wife was one of the pioneer teachers of this county and is considered a woman of ability. Four sons were born to this union, 2 survive and are well known: **John A.** of Oklahoma City, Oklahoma and **Frank H.**, now residing on the old homestead. The mother passed away about seven years ago leaving her husband in the care of son Frank and wife. On Friday, March 15, Mr. Burt passed away after a lingering illness at the age of 80 years, and 5 months. In the death of Mr. Burt the county loses one of its oldest and best known residents. He came in the early times when the work of a farmer was anonymous with that of pioneer. In 1855 he hauled lumber from Stevens Point to build the barn now standing on the old homestead. Like all farmers of his time, he met with many reverses but being determined to surmount all obstacles he finally rose to affluent circumstances. Through the

combined effort of himself and his wife, he secured a competency and lived for many years to enjoy his well earned home. He was engaged chiefly in stock raising. In politics Mr. Burt was a Democrat but never allowed his name to appear for office. He was also a member of many years standing in the Albany Masonic Lodge. Services were conducted at the homestead Sunday afternoon by Rev. Palmer of Monroe and the remains interred in Albany, services there being conducted by Brother Burr Sprague of Brodhead.

Artemus Silver died at his home in this village on Sunday night from the infirmities of old age from which he has practically been helpless for several years. The funeral was held for the house yesterday at 10:00, Elder E.P. Graves conducting the services and his remains taken to the Exeter Cemetery for interment.

Artemus Silver passed from this life at his home in Albany on March 17, after an illness of about five years during which time he was unable to walk. The funeral was held from the house on March 20 being conducted by Elder E.P. Graves and the remains taken to the family lot in the Exeter Cemetery for interment. The deceased requested Elder Graves 12 years ago to preach his funeral sermon if the elder survived him. Elder Graves also conducted the funeral services of Mrs. Silver who passed away six years ago last October. Mr. Silver was a genial gentleman and much esteemed by all who knew him and until his mental faculties failed him, was very companionable and was a man of wide knowledge. Mrs. Silver also was a well educated lady and one of the pioneer teachers in this section. The following is from the Green County history: Artemus Silver, one of the pioneers of Green County was born at Salem, Pennsylvania on Dec. 11, 1822. When he was 3 years old his parents moved to Mercer County where he was reared to agricultural pursuits. In 1844 he came to the territory of Wisconsin and visited Green County but did not settle here at that time. He returned to Mercer County where he was married on March 12, 1845 to **Harriett Colton** a native of Chautauqua County, New York born on October 21, 1824. Five weeks later they started for Wisconsin. They came by way of the Ohio and Mississippi Rivers to Galena and completed their journey to Green County over land. They stopped three weeks in Monroe where he rented a piece of land and put in a crop and came to Mt. Pleasant and lived with **Pliny Colton** until fall. He then entered 40 acres of land on Section 11, Township 3, Range 8 East now known as Mt. Pleasant. At the same time he laid claim to other lands, hiring men to enter the same at 25%. He first built a log house which they occupied 8 years afterwards building a good frame house. He engaged largely in raising grain and stock. They had six children three of whom are living: **Truman, Marvin and Flora**.

Daniel H. Morgan, a resident of Albany who has lived in Green County since 1852 died at the home of his son, **Dr. S.J. Morgan** in Albany on Monday, Sept. 23 at the age of 85 years and 3 months. The deceased in his prime was one of the strongest men of the county and served the county in the office of County Superintendent of Schools for 13 years, as County Surveyor for 20 years and as Registrar of Deeds for one term. He enjoyed good health up to last winter when a siege of sickness left him weak and from that time on he had been unwell. His condition the last few weeks had been very poor and the end, which was due to a general breakdown, was unexpected by relatives and many friends. The deceased was born in Brecksville, Cayuga County, Ohio on June 27, 1822. His father, **Isaac Morgan** was a native of New York state and his grandfather was a noted physician of the east and a graduate of Yale College in 1761. Deceased was the youngest of nine children and is the last of his

family to answer the final summons. He grew to manhood in his native village and received his early education in the district school. He afterwards attended five terms in the Brooklyn Academy in Cayuga County and at Richfield Academy in Summit County. At the age of 19 years he engaged in teaching school in his native town. He continued teaching there until 1852 when he came to Green County and taught two terms at Monroe. He then went to Jordan and purchased an interest in a saw mill there and then sold out and engaged in farming one year in Sylvester. In the spring of 1858 he bought land on Section 36 of Mt. Pleasant. There were 13 acres broken and a log cabin upon the place at the time of his purchase. He was thorough in all his undertakings and he converted his little patch of ground into a model farm home adding buildings, planting fruit and shade trees and tilling the soil. On March 23, 1845 he married **Cordelia L. Walling**, a native of Charlotte, Chittendon County, Vermont and to them were born nine children. His wife died many years ago and he later remarried. Mr. Morgan was first elected to the office of County Superintendent of Schools in 1867. He was re-elected in 1869 and again in 1871 and 1873 making 8 consecutive years in office. **Thomas C. Richmond** then held the office for two terms and Mr. Morgan was again elected and served five more years as County Superintendent. He was elected to the office of Registrar of Deeds and served one term and was County Surveyor for 20 years besides holding minor offices in his town. Deceased was a hard worker and a good business man never shirking duty in his public life and gave the public affairs the same consideration that he did his own. He was one of the best known men in the county and always a gentle and courteous gentleman at all times. He is survived by his wife and six children; the latter being **Mrs. Mort Whitcomb, Mrs. Joshua Wood, Charles Morgan, S.J. Morgan and Richard Morgan** of Albany; **Dr. Jennie Morgan** of Santa Cruz, California. The funeral was held on Wednesday afternoon at 1:00 at the home of S.J. Morgan, conducted by Rev.
