### January 4, 1893

Married, at St. Victor's Church by Rev. Father Dempsey, on Wednesday, Jan. 4, **Fred Sickinger** to **Nellie Knight**.

**Mr. and Mrs. Bert Galuska**(?) will soon depart for Flandrau(?), Moody Co., S.D., where they will go into business.

**Jacob Adams** went to Albany this morning having been summoned there on account of the illness of his brother-in-law **H. D. Putnam** who is dangerously ill with consumption of the bowels.

**Peter Tschudy**, brother of **Jacob J. Tschudy, Sr.**, of S.D., who has been visiting his brother in this city, left for his home this morning.

### January 5, 1893

**Mrs. Loris Wild** died at her residence in this city yesterday morning after a short illness. Her remains were taken to York in this city this morning for burial.

Married, on Dec. 23, 1892, at the Congregational parsonage by Rev. J. Schofield, **Jay Lewis** to **Louisa Marshall** of the town of Exeter, Green County.

**Mrs. George Lumoroux** of Minneapolis, Minn., who has been visiting her sister **Mrs. George Gay** for the past week left for Chicago this morning on a business trip.

### February 1, 1893

On Tuesday, Jan. 31 at 4:00 pm, **Mrs. George W. Banks** was called to rest after a lingering illness after about (*illegible words*.) She was a native of Groveland, Mass., but came to Green County at an early date with her husband who established himself in business. She leaves a husband, one daughter and three sons. She had suffered greatly for months from a tumor but during all her suffering she made but little complaint and bore her affliction with Christian fortitude. The poor ever found her to be full of charity that gave liberally and this cannot fail but to bring its reward. The funeral will take place at her late home tomorrow (Thursday) afternoon at 2:00.

### February 15, 1893

Juda: **W. F. Grenzom, Sr.**, died at his home near Twin Grove, Thursday, Feb. 9 aged 58 years, 8 months. The funeral services were held in the Union Church Saturday.....**Mrs. Hutzell** was summoned to Brodhead Sunday on account of the sickness of her daughter **Mrs. Cleveland**.....**J. S. Brown** has recovered from his recent sufficient to be able to go to Janesville with his daughter **Mrs. Chadwick**.....News has just been received of the death of **Mrs. F. Enfield**, one of the old settlers of Decatur Township having lived at her late home three and a half miles northeast of Juda for nearly fifty years.

**February 22, 1893**

Juda: **Mrs. A. Riley** died Tuesday afternoon at 3:30.

**February 25, 1893**

Last night when **John K. Parks** returned home from his work for supper he found his wife dead. She had been in the best of spirits yesterday and ate a hearty dinner and in the afternoon was engaged in making bread. She had baked the first loaf and the oven contained the second batch when death overcame her. Mrs. Parks was subject to sinking spirits and sometimes was hysterical and perhaps had a bad spell and went to her bedroom to rest. She had a bottle of medicine to rub on her side containing four ounces of alcohol and two ounces of chloroform and the finding of the coroner's jury after viewing the remains was that she came to her death by her own hands from the effects of this medicine as there were two cloths wet with liniment which were under her nose and one by the side of her face and traces of chloroform prevailed in the house when the doctors arrived.

**March 1, 1893**

Juda: Information was received of the death of **Mrs. Ezra Carmer** who for many years was a resident of Juda.

**Annie Elenfelt Banker**, the 11 year old daughter of **Mr. and Mrs. F. A. Banker**, who reside at the corner of South River and Union Streets, had been sick for two weeks. She had been first taken with diphtheria and blood poisoning followed which resulted in her death. When their residence was quarantined, eight of the eleven members of the family were home. The family consists of the parents and nine children and occupied two rooms. They lived in one and slept in the other. When the disease broke out the family took care of the boy and girl who had first come down with it. The other members of the family lived in the wood shed for ten days and are there now. The girl has died and the boy is well but the father and boy cannot leave the room until they are cleansed. Dr. Gibson said it was the dirtiest place he had ever been in. In the other side of the house another family of eleven live. Miss Banker was buried last night. Janesville Recorder

**April 3, 1893**

Birth to **Mr. and Mrs. John Milliman** on Saturday morning. *(no information was given as to whether it was a boy or a girl.)*

Birth to **Mr. and Mrs. Wm. Ellis** of Jordan on Easter Sunday, a son.

Birth, to **Mr. and Mrs. Robert Kren** on Easter Monday, a son.

**Mrs. Nellie A. Palmer**, wife of **Newton N. Palmer** of Rock County, and sister to **Barr Sprague**, died at noon Saturday, April 1 at DeFaniak Springs, Florida of heart disease. Mr. Palmer had been an invalid during the past year and Mr. Palmer took her south with the hope of improving her condition. Their two daughters are also with them. They started on their sad journey home last evening.

**April 7, 1893**

**May 1, 1893**

**Mrs. Daniel Flynn**, one of the oldest citizens in this city, died at her residence near the cemetery Sunday night about 10:00 from the result of a paralytic stroke some two weeks ago. The funeral will take place from St. Victor's Church tomorrow at 10:00.

The funeral of **Mrs. John Calendine** took place at 10:00 this morning from the Willet Church. Mrs. Calendine died at her residence in the town of Washington Saturday morning.

**May 3, 1893**

Juda: Tidings were received Saturday night of the death and funeral of "**Grandma**" **Hubbard** of Sylvester. The many who have been so kindly entertained beneath her roof will sorrow with her children who so deeply feel their loss.

**May 10, 1893**

Juda: **Miss Lizzie Asmus** married **G. B. Lahr** Thursday night, May 4 at 8:00 at the residence of the bride. About thirty guests were present mainly relatives. **Rev. Wm. Lahr**, father of the groom, assisted by Charles Kuntz, officiated.....**Mrs. Charlotte Preston** came home from Madison Tuesday where she has been visiting her daughter **Mrs. W. S. Pengra** since January.....**Mrs. Briggs** is enjoying a visit from her niece **Mrs. Lancy** of Missouri who will remain a month or more.

**June 1, 1893**

Today we have to announce the death of another old and respected citizen who has resided in Green County for over 40 years. **Mrs. Mary Hamilton** died on June 1 at 9:15 a.m. after a long and tedious illness caused by dropsy and heart disease. The death of this esteemed lady took place at the residence of her daughter **Mrs. P. J. Johnson**. Mrs. Hamilton leaves three children and many friends to mourn her death. She was about 70 years of age.

**June 2, 1893**

Another of the old residents of the city has passed away. **Mrs. Elizabeth Fowler** died yesterday at the residence of her daughter Mrs. Wilson on Fulton Street at the age of 71 years. She was born in Braceville, Ohio and came to Wisconsin in 1845 and since that time has lived in Lafayette and Green Counties. Her husband died some time ago and he was the first postmaster in Argyle. For the last 14 years her daughter, **Mrs. Welsa**, has held a sealed envelope to be opened after her death and in it was found a list of names of pall bearers and the text she wished to be used in preaching her funeral. The funeral took place this afternoon at 2:00 with Elder Goodacre conducting the services.

**July 13, 1893**

From the Freeport Democrat of July 11: To be married at Monroe, tomorrow morning, **Miss Mabel Burrington** of Browntown, Wisconsin and **Charles McCoy** of Picketts, Wisconsin. They will be married by Rev. Father Dempsey. The groom is the agent for the Central at his home and is a son of ex-Alderman **A. J. McCoy** who will attend the marriage as will also ex-city clerk **Thomas D. Osborne** and wife. The young couple who will be married will reach her next Thursday.

**July 14, 1893**

The people of Monticello and vicinity will be grieved to learn of the death of **Lizzie J. Roby** which occurred at her home in Evansville, Wisconsin June 13. She was the daughter of **Elijah Roby** one of the oldest settlers of Green County. She was born in Licking Co., Ohio on Oct. 30, 1848 and came with her parents to Wisconsin in 1844. They settled on a farm near Monticello which was her home until 1882 when they sold the farm and moved to Evansville. Her life has been one of patience, self sacrifice and care. For some years she has been patient in doing the work she had to do in taking care of the home and a sister who has been in poor health. The funeral services were held at the home with Rev. Stevens of the M.E. Church officiating. His text was "she did all she could." Monticello News

George located in Waukegan and it seems that though they were both there to see the fair they decided to get married and the knot was tied. They will locate at Waukegan, Illinois. The bride's father is a well known engineer on the Northwestern Road.

**September 1, 1893**

**Earnest Graves**, the young married man in jail awaiting trial for criminally assaulting an eleven year old girl, was up before Judge Abbott this afternoon. His trial was laid over until next Tuesday.

**William Schuler** was pulled yesterday for being drunk and disorderly. He was up before Police Justice Dunwiddie this morning and fined \$26 or 40 days in jail. He was re-taken to the cooler where he will remain forty days.

Vernon Cemetery in Juda today. ....**Mrs. Lancy** who has been spending the summer with her aunt **Mrs. Briggs**, returned to her home in Missouri on Tuesday.

**October 23, 1893**

Monticello: **Mrs. Frank Magoon** of Hawkeye, Iowa, arrived on Tuesday morning to attend the wedding of her brother **J. Burton Pierce** .....The marriage of **Pat Doyle** and **Mary Ann Carroll**, daughter of **Mr. Anthony Carroll**, all of Mt. Pleasant, was announced after the event on Tuesday the 17th .....**John O'Donnell, Sr.**, was considered dangerously ill last week but is now thought to be improving somewhat. An abscess on his neck discharged large quantities of blood which for several days refused to yield to medical treatment.

**November 3, 1893**

Married, on Thursday evening, Nov. 2, at the parsonage at St. Victor's Church, by Rev. Father Dempsey, **Clarence Hill** and **Susie Moni**, both of this city. **Mr. and Mrs. John Sickisger** acted as best man and lady.

Married, on Tuesday evening, Oct. 31, at the M.E. parsonage, by Rev. I. F. Nazum, **S. M. Howe** of Wakonda, S.D., and **Hannah Rockey** of Monroe. Mr. and Mrs. Howe left for their western home this morning.

**Mr. and Mrs. Wm. Parks** who have been visiting in this city the guests of Mrs. Parks' parents, **Mr. and Mrs. Michael Bennett** and family, for some time past, left this morning for their home in Hampton, Iowa.

#### December 2, 1893

**Mrs. J. S. Bloom** returned from Minneapolis yesterday. She was called here by the dangerous illness of her husband.

#### December 5, 1893

There was a quiet wedding last evening at the home of **Mr. and Mrs. John S. Niles** in the south part of the city. The parties were their son **Thomas** and **Edith Wagner** and the attendants were **Fred Miller** and **Miss Rose Wagner**. **Rev. C. F. Niles**, brother of the groom, performed the ceremony. Only relatives of the interested parties were present. The happy couple are well known to the city having been born and raised here. The groom conducts a plumbing business in this city and is a man whose conduct and energy has won him the high esteem of all who know him. A pleasant home has been prepared in the southern part of the city where the young people will reside.

Funeral services over the remains of the late **J. S. Bloom** were held at his old home on East Street at 10:00 this morning. Rev. I. F. Nazum officiated. There was a large attendance of friends and neighbors.

**Dr. J. D. Soseman** and wife returned from South Bend, Indiana last night. They were called there by the sickness of Mr. Soseman's father and mother. While there, his mother died at the age of 73 and his father is improving.

### December 14, 1893

As the Illinois Central passenger train came thundering into the city about 6:30 last evening another name was added to the long list of those who have fallen victims. A man was struck and killed at Young's Crossing, was the brief report that spread through the city like wild fire. It proved to be true. In the dark in the Illinois Central freight house, with no lights except the mellow blaze of a lantern. A face covered with blood and blood oozing from his eyes, nose and ears, an open mouth closed with clotted blood, steamed in the cold night air, told the awful truth that the flying locomotive had done its deadly work. A crowd assembled and the dead man was soon recognized as **Fred Leauty**, a farmer living near Jordan. He is a son-in-law of **Jacob Kundert** of this city who was sent for and the scene that followed his arrival was pathetic indeed and strong hearts turned away. The old gentleman completely broke down. A wife and seven children mourn his loss the youngest two months old. He was 36 years of age.
