January 5, 1895

Married, at Monroe, on New Year's night, at the residence of **Mrs. Mary A. Lichtenwaiser** of this city, **Nettie Lichtenwaiser** to **George Whitehead** of Twin Grove. There were between 30 and 40 guests present. They will reside on a farm in Twin Grove.

January 7, 1895

Miss Edith Raymer, the 14 year old daughter of **John Raymer** of Cadiz died of heart trouble last night after an illness of five weeks. The funeral will be held at 1:30 tomorrow afternoon from the Cadiz Church.

Birth, to **Mr. and Mrs. A. Miller** last night, a daughter.

January 8, 1895

Len Cheney announced the marriage of his niece **Miss Elizabeth North** to **Arthur H. Young**, of Wauwatosa on Jan. 1.

Carl Drueger died at his home of his son **Hiram** in Monroe Monday afternoon at 4:00 at the age of 79. Funeral services will be held from his late home on Wednesday at 12:30.

January 9, 1895

Juda: **James Mitchell** died at his home in Decatur Thursday noon and was buried from the Baptist Church Sunday morning.

Married, yesterday, in this city by Rev. Thomas Dempsey, **Millie Clayton** to **James Tobin**.

January 12, 1895

Mrs. Lou Layton had a warrant sworn out against **Andrew Layton** as accessory to the crime whereby her husband was obliged to spend thirty days in jail. The hearing was held before Justice Caradine and he was sentenced to 15 days with Sheriff Duerst.

January 15, 1895

Married, in this city last week by Court Commissioner John Ludsing, **Richard Lunt(?) Lust(?)** of Mt. Vernon, Dunn Co., to **Miss Annie Ott** of Monroe.

January 19, 1895

Patrick Dwyer died at 10:30 last evening at the home of his son **James**, one half mile north of Browntown.

The little boy of **Mr. and Mrs. John Clark** of Juda died at 8:00 this morning of lung fever. The funeral will be held tomorrow.

January 21, 1895

Sad, indeed, was the summons that called **Mrs. Juliana McFarland** from the world of sorrow and strife. Her death occurred at 9:30 this morning after a brief illness. She had been in good health until pneumonia became apparent about a week ago. She was taken very ill but a decided improvement followed and even yesterday the family was encouraged by her condition. She was about 80 years of age. The family came to this city about twenty years ago from Chillicothe, Ohio and her husband preceded her about 12 years ago to the land of rest. She had resided in the home where she died for many years and was highly respected. She was an Episcopalian in religion. She leaves to mourn her loss six children, one son and five daughters: **Mrs. Brown** of Battle Creek, Michigan; **Mrs. G. W. Prescott** of San Bernardino, California; **Mrs. Sue Taylor** of Denver; **John McFarland** of California; **Mrs. J. K. Symonds** and **Mrs. Juliana Wattles** of this city. Funeral arrangements will not be made until the children have been heard from.

January 24, 1895

The marriage of **Fred Burt** to **Miss Amelia Zabel** will occur at 8:00 this evening from the groom's parents' home on East Street.

The funeral of **Mrs. Juliana McFarland** will be held at 2:00 Sunday afternoon from her late home on East Washington St.

January 25, 1895

A happy wedding took place at the home of **Mr. and Mrs. Rudolph Burt** at 8:00 last evening when their son **Fred** was united in marriage to **Amelia Zabel**, by Rev. Theo Tanner. The bride and groom were attended by **Miss Annie Zabel**, sister of the bride and **Fred Karlen**. The bride is the daughter of **Mr. and Mrs. Christ Zabel** of this city. She has spent much of her life in this city and is highly esteemed by her friends. The groom is the junior member of the grocery firm of Bauman and Burt and is well known to our readers.

Married, in Monroe on Tuesday at 11:00 at the residence of the bride's parents, **Mr. and Mrs. Christ Wenger**, by Rev. Gaurky, of the German Methodist Church, **Lydia Wenger** to **Fred Stauffacher** of Sylvester. They were attended by **Bertha Wenger**, sister of the bride and **Frank Stauffacher**, brother of the groom. The happy couple will reside in Sylvester.

January 26, 1895

A five month old son of **Mr. and Mrs. Anton Postman** of Monroe died yesterday.

January 28, 1895

In the midst of a large number of friends, the last sad rites over the remains of **Mrs. Julia McFarland** were conducted yesterday at 2:30 in the afternoon from her late home. The Episcopal funeral service was lead by Rev. F. H. Barton and Rev. Dana. The remains were interred beside her husband who preceded her in death. The pallbearers

were **D. S. Young, A. S. Douglas, Felix Bennett, S. P. Schadel, Stephen Miller** and **W. W. Chadwick**.

Mrs. Andrew Warner died at her home in the town of Jordan Sunday morning and will be buried Tuesday. Mr. Warner is also very ill.

January 30, 1895

Juda: A grandchild of **Mr. Ostrander** was brought from Iowa and buried at the Union Church, Rev. Anderick officiating.

February 4, 1895

Birth, to **Mr. and Mrs. William Ludlow**, a son. Outside of his father, he is the only man in the house. There will be nothing too good for that boy.

February 14, 1895

Married, at high noon today by Rev. Beidler at their new home in the 3rd Ward, in the presence of about 30 friends, **Allie Zilmer** and **Martha Schneider**. They were attended by **Emma Zilmer**, sister of the groom and **John Schneider**, brother of the bride.

Up to last March, there lived in this city **Mr. and Mrs. W. W. Warner**. W. W. Warner is a son of **John Warner** of this city and at present resides at Turtle Lake. By adoption, they were made the parents of a little girl of doubtful origin after the accused father was acquitted in a case before the Green County Court in the Fall of 1893. On August 6, 1894, the little child died under strange circumstances. Further investigation was lent to the case by a Minneapolis dispatch under the date of Feb. 14:

This morning Sheriff F. B. Waterman of Barron Co., Wisconsin, arrested **Charles Patterson** and **Mrs. Ada Warner** on the charge of murder in the first degree. The two were found living in a room at 517 Washington Avenue, North, in this city. The sheriff has been following different trails since August 3 and only a few days ago did he run upon the one that brought him upon the two fugitives.

The two were charged with the murder of **Belle Warner**, the 18 month old daughter of **Ada and W. W. Warner** of Turtle Lake, Wisconsin. The little one died under very suspicious circumstances on Aug. 3 and the inquest revealed she had been poisoned. The poisoner could not be located as at first the mother of the infant was not under suspicion at all but in a few days the community was startled to learn that Mrs. Warner had disappeared in company with Patterson. The father of the dead infant was almost beside himself and after he told the police of his wife's relations with Patterson, evidence was discovered that connected the fugitives with the crime. The night that the child was poisoned the father was away from home and returned just in time to see the child dead. The motive assigned to the crime is that the mother found the child to be a barrier to her relationship with Patterson. The two were taken to Turtle Lake this afternoon at 2:30.

March 2, 1895

Mrs. Mary Southern of West Marshfield, Ohio, who has been spending the winter with her daughter **Mrs. Stephen Miller**, left for Ft. Atkinson yesterday afternoon.

March 4, 1895

John Danner died yesterday morning at Shueytown after suffering from consumption. The funeral will be held tomorrow at 1:00 from his late home.

Mr. and Mrs. Albert Hoehn, Mrs. Gerard Kneeland, and Miss Carrie Kneeland are at the Winslow to attend the funeral of the 8 years old daughter of **Mrs. Blanche Bunker**, which was held this afternoon.

Shortly after 8:00 Saturday evening at the residence of the groom, H. N. B. Caradine united in marriage **J. H. Parks** of this city and **Mrs. K. E. Dewey** of Chicago. They will reside in this city.

Mrs. George Guy received a telegram today announcing the death of her mother at Clear Lake, Minnesota. Several weeks ago she was called to her bedside and returned, leaving her mother much improved.

James Sullivan of Mason City, Iowa, will arrive in the city on the 10:37 passenger train tomorrow morning with the remains of his mother. They will be taken from the depot to the cemetery for interment. She formerly resided here.

Birth, to **Mr. and Mrs. J. Wallace**, a daughter, eight and a half pounds.

March 5, 1895

The remains of **Mrs. James Sullivan** arrived in this city this morning from Mason City, Iowa and were taken to the Catholic Cemetery for burial. A large number of friends who had not forgotten her followed the remains to the last resting place. Her two sons, **James** and **John**, with other relatives, accompanied the remains to this city.

Mrs. Cutheran left this morning for Westfield, Wisconsin where she will reside with her daughter **Mrs. Harvey Lichtenwalner**.

March 6, 1895

Sorrow followed swiftly on the heels of joy at the home of **Mr. and Mrs. John Walker**. Sunday evening a bright little girl came to them. It proved to be a treasure loaned but a short time for this morning it closed its eyes in death. The funeral was held this afternoon at 2:00.

Christian Street, a brother of **Mrs. Godfred Karlen** who resides at the Illinois Central Depot died last night of dropsy. He was about 50.

Birth, to **Mr. and Mrs. C. W. Twining**, a son.

The funeral of **Christian Street** was held at 1:30 this afternoon from the home of **Godfred Karlen**, near the Illinois Central Depot.

March 8, 1895

Frank Crawford, who came to this city some years ago with **Frank Warren**, and was employed in the livery stable is well remembered here. He appears to be a fiend in human flesh. The following item is from the Wisconsin State Journal published at Madison:

Frank Crawford, coachman for three years at the Hess & Schmidt stables dismissed Monday night together with **James Grady**, a former employee of the stable leaving some \$70 worth of bills unpaid and a young girl formerly **Miss Sadie Karls** of Pine Bluff and now the adopted daughter of **Mrs. Aug. Reuter**, 450 West Gilman St., who says she is his wife. She says they were married Nov. 19, 1894 at Madison and he has lived at the University Hotel where she has worked. Crawford has always denied to friends that they were married.

March 11, 1895

Mrs. John Zimmerman and little child of Beloit arrived in this city this morning to visit her mother **Mrs. E. Zweifel** who is in poor health.

Mr. and Mrs. R. C. Bocher(?) Bouher(?) go up to Monticello this evening to attend the funeral of a little child of **Mr. and Mrs. S. C. Walters** which will be held tomorrow.

March 12, 1895

Mr. and Mrs. John Bauman went to Clarno last night to attend the funeral of **Miss Katie Gebhardt**, a cousin of Mrs. Bauman's, which was held this forenoon.

March 21, 1895

Married, at high noon today at the farm house of **Fred Tschudy** one and one half miles southeast of this city, his eldest daughter **Lulu** to **Jacob Burgi**. They were attended by **Miss Olli Bungi**, sister of the groom and **J. J. Tschudy**, brother of the bride. The ceremony was performed by Rev. Theo Tanner, of St. John's Episcopal Evangelical Church of this city in the presence of a small company of friends and relatives. The happy couple will take up their home on a farm near Monticello. They depart on the afternoon train for Chicago where they will visit for a few days.

March 22, 1895

Twice in less than a day but a few hours intervening, the death messenger entered the household of the Liddell family land summoned the father and the eldest son. **Rev. Liddell** was until recently located in this city and was the M.E. circuit preacher of this district. He was taken ill some time ago with la grippe and it developed into pneumonia and caused his death. He passed away at 2:00 yesterday afternoon. He was about 45 years of age and was held in high esteem. **Edward E. Liddell**, his oldest son, was also a victim of pneumonia. Before his father was cold in death he too was summoned to the far beyond. His death occurred at 6:00 this morning. He was 19 years of age and at the time of his death was a member of Company H, 1st Infantry Wisconsin National Guard of this city. The remains of the

father and son will be taken to Millbrig, Illinois their former home, for interment. Mrs. Liddell is in poor health.

March 23, 1895

Juda: **Mrs. Daniel Dunwiddie** died here at 2:45 pm. A stroke of paralysis a few days ago was the cause of his death.

Married, on Thursday, March 21 by Court Commissioner John Luchsinger, **Gottlieb Nettemschwander** of the town of York to **Sophia Grunner** of the town of Adams.

Married, on Friday, March 22, by Court Commissioner John Luchsinger, **Ulrich Wuethrick** to **Minnie Zindel**. The parties reside at Monroe.

March 25, 1895

After suffering but a day from a severe attack of kidney trouble, **Miss Kate Daugherty** passed away at her home south of the city about 4:00 Saturday afternoon. She had been ailing some time but nothing serious was expected and her death was a great shock to the family. She was about 35 years of age and was an amiable lady. Her funeral was held at 10:00 this morning from St. Victor's Church.

March 27, 1895

Juda: **Luke Edwards** of Sylvester was buried on Saturday.....Birth, to **Mr. and Mrs. Gibson**, a son.....**Judge Dunwiddie** and family were here to attend the funeral of **Mrs. Daniel Dunwiddie**.....**Mrs. J. C. Chadwick** returned from Janesville Tuesday morning in company with her niece **Miss Flo Dunwiddie**, and **Mrs. B. F. Dunwiddie**.

April 1, 1895

Among the young men of this city none were held in higher esteem than **Albert B. Greenwald**. His was a life of industry and business. He may not have been widely known. On Saturday when the news of his untimely death was announced, many said he was an honorable, fair, faithful young man. He was the son of **Mrs. Catherine Greenwald** and all his life was spent in this city. At an early age he became a skilled tinsmith and with a small beginning, through his persistence there came into his possession a prosperous hardware business. But he was not long allowed to enjoy its fruits. For a brief period last summer he was not well but seemed to regain his health. A few weeks ago he was again taken ill but his illness did not excite alarm until congestion of the lungs had done its awful work. He was making a favorable improvement and during his illness he never felt better than he did fifteen minutes before his death. He was taken with a sinking spell and at 3:00 Saturday sank into a lasting sleep. He was 28 years of age. A devoted wife of little more than a year, a widowed mother and brothers are left to mourn their loss. The funeral will be held tomorrow afternoon at 2:00 from his late home and at 2:30 from the German Lutheran Church.

Mrs. L. J. Bryant who has been in the city for the past three months caring for her mother **Mrs. Sutley** left this morning for her home in Washington, D.C.

Mrs. Robert Guthrie who was summoned here on account of the death of her mother **Mrs. J. S. Bloom**, left for her home in Superior, Nebraska this morning.

Mr. and Mrs. A. F. Moore and son arrived in this city last evening and are the guests of **Mr. and Mrs. Charles French**, a sister of Mrs. Moore.

April 3, 1895

Juda: **Mrs. James Roderick** is in Clarno caring for her sister **Mrs. James Davis**. . . . **Isaac Newman** and **Lean Bloom** were married at the Baptist parsonage on Sunday morning by Rev Mr. Anderick.

Birth, to **Mr. and Mrs. M. M. Newton Millington**, today, a son.

April 4, 1895

Mrs. Jacob Karlen accompanied by her daughter **Mrs. John Warren**, left this morning for Bufflao, New York to visit her daughter.

Mrs. G. T. Hodges gave a dinner Tuesday for her brother and sister. Those present were **Mrs. Isabel Flanders** of Chicago; **Mrs. Graham** of Minneapolis; **Mr. and Mrs. James Banks** of Ft. Atkinson; **Mrs. C. A. Lytle** and **Mrs. G. T. Hodges**. It is the first time in 28 years that the four sisters have been together.

Mrs. J. B. Miller, for 15 years a resident of this city, died at 4:00 yesterday afternoon at the home of her daughter **Mrs. A. J. Post** at Chippewa Falls. She was about 78 years and left this city about a year ago. She is the mother of **E. H. Miller** who still resides here. The remains will arrive in the city tomorrow and the funeral will be held at the residence of E. H. Miller at 2:00.

April 5, 1895

Monticello: The many friends of **James Moore** will be sorry to learn that he is at present suffering from a severe attack of pneumonia. . . . **Albert Stoller** went to Monroe Tuesday afternoon to be in attendance at the funeral on the following day of his uncle, **John Stoller**. . . . **J. H. Berkey** contemplates removing his family to Monroe, he having purchased three lots in the northeast part of the city and will erect a residence there in the near future.

A sister of **Mrs. George Gay** of Clear Lake, Minnesota arrived in the city this morning called here on account of the illness of Mrs. Gay.

On Friday, March 29, **Thomas G. Wright** of Mineral Point celebrated his 80th birthday with a family reunion. He is the father of **Colin W. Wright** of this city who was present.

Miss Alecta Stauffacher of this city and **Oscar S. Hogen** of Lisbon, Illinois were married in this city last evening by Rev. J. Elmer at the residence of the bride's parents, **Mr. and Mrs. Isaacs**.

Mr. and Mrs. J. R. Campbell of Eau Claire and **Mr. and Mrs. A. B. Bast** of Chippewa Falls were here to attend the funeral of **Mrs. J. B. Miller**.

April 6, 1895

Mr. Charley Emerson who has been spending the past six months with **Mrs. Margaret Emerson** left Monroe about two weeks ago with her four month old baby to journey to her home in far away Montana. She made the railway journey in safety but was still 85 miles from home. While waiting there for suitable weather in which to cross the country, the little one was taken suddenly ill with cholera infantum and died. Charley Emerson is one of Monroe's boys. Mrs. Emerson during her stay here has made her husband's friends her own.

April 8, 1895

Miss Kittie Kelly, the 15 year old daughter of **Mr. and Mrs. Mack Kelly** is very low with hemorrhage of the lungs.

Nelson Andrews of the town of Sylvester died at 11:00 Saturday night. He had been sick last September from a cancer on the knee which was the cause of his death. During his illness, his limb was amputated twice. He was 19 years of age. The funeral will be held from the church at 11:00 tomorrow.

April 10, 1895

Married, at the residence of **Dan Howver** on Sunday afternoon by Justice Abbot, **George Kennedy** to **Miss Fanny Sparks** of Winslow.

Jacob Clomes of Clarno died this morning at the home of **Joseph Knipschid**. Dropsy is the cause of his death. He was 81 years of age. The remains will be shipped to Dane(?) Station tomorrow.

G. B. Russell, landlord of the Goodwin House at Beloit, died suddenly of apoplexy Tuesday night. Interment was at Danville, Illinois today.

April 13, 1895

Jacob J. Tschudy, son of **Fred Tschudy**, left this morning for Calhoen(?), La., where he will have charge of an experiment station controlled by the State of Louisiana. He is a graduate of the dairy and agricultural department of the Wisconsin University.

Mrs. George Farrigar, **Anton Sery** and **Matt Sery** of Milwaukee and **Joe Welter** of Sheboygan who were here to attend the funeral of **A. Sery**, returned to their homes today.

Invitations for the marriage of **Grace Coon** of Edgerton, daughter of **Mr. and Mrs. F. W. Coon** and **D. Frank Hedder** of Evansville which will occur at Edgerton at the Congregational Church on May 2, have been received in this city. The groom is a lumber merchant in Evansville.

Funeral services over the remains of **John S. Harper** were held at 10:00 this morning from his late home and were conducted by Rev. C. F. Varney of the Universalist Church. The Masonic Lodge of which he was a member, attended

in a body and at the grave the service was according to the Masonic ritual. Pall bearers were **J. Bolender, Thurm Crago, A. S. Douglas, P. W. Puffer, Josh Struff** and **N. B. Treat**.

Nettie Hirsig, daughter of **Mr. and Mrs. Wm. Hirsig**, fell from the banister in front of the high school building shortly before noon today. She was picked up unconscious and serious injury is feared.

April 15, 1895

Married, by Rev. Beidler, on March 15, at the home of **L. Stevenson, Miss Ollie Hall** to **Clint Blair**.

John Brown, a teamster living in the western part of the city, was judged insane Saturday afternoon and will be taken to the asylum at Mendota for treatment. He was despondent on account of not being able to get work, and this is the supposed cause.

Mrs. Louise Home (or Horne), relict of **Fred Home (or Horne)**, whose foul murder about 15 years ago created the most interesting murder case ever held in Green County, died last night at the home of **Herman Coptine (or Capline)** in the township of Sylvester. She was 73 years of age and she suffered from lung fever. The funeral will be held Thursday at 10:00 from the Dutch Hollow Church.

Wm. McDowell, father of **Charles McDowell** of this city, died on his farm 6 miles southwest of this city at 8:00 yesterday morning. He was 98 years old and supposed to be the only surviving member of the convention that met in 1848 and formed the constitution making this state. The funeral will be held tomorrow at 9:00 from the late home and interment at Cedarville, Illinois.

April 19, 1895

After a tedious illness which extended into many weeks, **Milt Hoesly** has at last been relieved by death. The end came shortly after noon and he was surrounded by his wife, parents, brothers and sisters and it was painless and peaceable. It was not unexpected as it became known a few days ago that he end was near as he grew weaker. He was conscious to the last and death came with his last utterance. Big, stout and apparently healthy, he fell a victim to consumption. He passed his life of 38 years, 5 months and 27 days as a popular young man, well liked for his kindly ways and pleasant nature. He grew to manhood in this city and it is regretted that he has been called early in life. He was a member of the Concordia Lodge I.O.O.F. A young wife survives him. The funeral will be held at 2:00 Sunday afternoon from his late home.

April 20, 1895

Mrs. Graham left this morning for her home in Minneapolis. Her sister, **Mrs. G. T. Hodges**, accompanied her as far as Brodhead.

The funeral of **Milt Hoesly** will be held at 2:00 tomorrow from his late home. The Odd Fellows of both the German and English lodges will be in attendance.

The remains of **Mrs. Cook**, widow of the late **J. J. Cook** arrived in this city this morning from Milwaukee where she died at the Old Ladies Home. The remains were interred at Greenwood Cemetery and was in charge of friends many

years ago who reside in this city.

April 21, 1895

Miss Anna Ennis and **Harry Phillips** of Janesville drove to Brodhead Friday and were married by Rev. Father Buckley. Harry is the son of **Edward Phillips** formerly of this city.

April 22, 1895

Daniel Maloney will be married next Friday evening, April 26, to the charming **widow O'Connor** on the stage of Well's Opera House. All friends and those who want to enjoy a good laugh will be invited to be present.

Funeral **Milt Hoesley** was described in detail in the newspaper but not transcribed here except for the following: His untimely death was most keenly felt by the presence of the two grandmothers of the deceased, **Mrs. Kendert** is 79 and had come from Milwaukee to attend the funeral and **Mrs. Hoelsy** is 88 and was also present. The parents of both the deceased and his wife were also present.

April 24, 1895

Invitations are out for the marriage of **Lizzie Sickinger** and **Hary Etley** which will occur at the residence of the bride's father Thursday, May 2.

Miss Maggie Flanigan and **John Devaney** were married at St. Victor's Church this morning. They departed on the train for Austin, Minnesota where the groom is employed on the railroad.

A. Sery is very low with pleurisy. He expected to go to Milwaukee this morning but was taken ill last night. He had been in poor health of late and just recovered from a severe siege of sickness.

April 25, 1895

Married, this afternoon by Rev. Theo Tanner, **Miss Louis Belong** to **Ed Karlen**. The bride has been engaged in the family of **Jacob Begez(?)** and the groom is a cheese maker. They will reside at Clark Co., Wisconsin.

Married, this morning, by Rev. Theo Tanner, **Miss Emma Reese(?)Reeser(?)** to **John Nederhauser**, both of the town of Jordan.

Mrs. J. H. Cook of Orangeville who has been visiting her sister **Mrs. Jas. Confer** of this city returned home this morning.

The funeral of **Isaiah Stauffacher** will be held Sunday at 10:00 from his late home and at 10:30 from the German Methodist Church.

April 26, 1895

The funeral of **John S. Harper** will be held tomorrow from his late home. The Masonic lodge will have charge of it.

Fritz Trachsel, an inmate of the county poor farm died today. He was brought there Friday from New Glarus and was dying then.

April 27, 1895

Mrs. John Zimmerman is in the city today. She is the daughter of **Mrs. E. Zweifel** who is in bad health.

After being dead ten or twelve hours, **John Harper** was found in his bed in his home on East Washington Street at 1:00 today. He retired about 9:00 last evening and nothing was seen since of him by his sister-in-law who resides at the same place. She went to his room and was unable to wake him. Dr. F. M. Confer was called and pronounced him dead with the opinion he had been dead ten or twelve hours. The circumstances under which he died are regretted. For the past few days he has been drinking considerably and he has been known to take morphine at times, it is thought to have been something to do with his death. With his vital forces reduced by drinking the usual dose of morphine would be sufficient to cause death. He evidently died without a struggle and simply sank to sleep. With the death of Mr. Harper the last member of the Harper family with whom he is connected is removed. His nearest relative is a cousin who lives in the east. He was about 72 years of age and was a resident of this city for over forty years. For many years he was in the hardware business, over 30 years in the stand now occupied by Streiff and Lewis. At the time of his death, he was a member of the firm of Harper and Johnson. His life was one of success and failure and he never wanted for the worldly goods. He was respected and liked by all. He was his own worst enemy. He was a member of a Masonic Lodge and the lodge will have charge of his burial.

Mr. and Mrs. Simon Herbert of Waukesha, **Miss Mary Sery**, **Mrs. Joseph Bell** and **John Sery** of Milwaukee were called here by the death of their brother and left for their home yesterday afternoon.

Jacob Adams left this morning for Superior, Nebraska. His location there is somewhat indefinite and should he desire to return to Monroe this community would rejoice as it can ill afford to lose such a good citizen.

May 3, 1895

At 1:00 last evening at the home of **Mr. and Mrs. Louis Sickinger**, their eldest daughter **Lizzie**, was married to **Harry Eley**. They were attended by **Miss Ann Beller** and **Arthur Sickinger**. Rev. J. A. Beidler of the English Lutheran Church officiated and the ceremony was witnessed by a company of relatives and friends that filled the house. The young couple have always resided in Monroe. The groom is a marble cutter employed by D. C. Ryan and is an industrious young man. They will reside on Emerson Street one block south of the St. Paul tracks.

May 4, 1895

The funeral of **Mrs. Frederick Gloege** will be held tomorrow afternoon from her late home and at 1:30 from the German Methodist Church.

Dr. J. D. Soseman was called to South Bend, Indiana yesterday on account of the sickness of his sister but before he arrived death had overtaken her.

May 14, 1895

May 28, 1895

Mr. and Mrs. John Powell of Pontiac, Illinois arrived in the city last evening. They are the parents of **Mrs. J. D. Honeywell** and both are in their 80th year.

May 29, 1895

The remains of **Miss Maria Bowden** arrived in the city last evening from Chicago. She was the youngest daughter of **Samuel Bowden**. She died of inflammation of the bowels at the age of 48. The family resided in this city until about seven years ago. Funeral services were held at the home of **Mrs. Ella Miller** at 2:00 this afternoon with Rev. I. F. Nazum officiating.

May 31, 1895

E. D. Perkins of Suisun(?), California has been in the city visiting his sister **Mrs. John Grinnel**. Together with **Mrs. Edith Grinnel** they went to Milwaukee this afternoon.

Mrs. Margaret Luchsinger died at New Glarus yesterday, aged about 70. She was the mother of **Mrs. C. R. Schepley**, **Thomas Luchsinger** and the late **Mrs. Zweifel**. She had been in a poor condition for some time past and during the latter part of Mrs. Zweifel's illness became unconscious.

Mrs. Carrie Nelson of Jordan Center died Wednesday afternoon, aged 87. The funeral was held today.

June 1, 1895

Mrs. P. W. Puffer attended the birthday anniversary of her mother in Janesville on Wednesday. The Janesville paper says:

Mrs. Annie Noggle, widow of the late **Judge Noggle**, has attained her 80th birthday in the best of health and with mind and spirits as bright as ever although she has been afflicted with total deafness for the past 15 years. She is certainly a real pioneer of the state, having come west with her husband in 1837 shortly after her marriage, moving to Beloit in 1839 and to Janesville in 1848. Mabel Kidd who has just finished the Modern Classical Course, a brilliant scholar and is a lovable girl. She is 20 years old and the daughter of **George Kidd** of Browntown. She will probably teach.

Charles Bolender attended the north building previous to entering the high school and has completed a four year Modern Class Course. He is the class treasurer and is 18 years of age. He is an exceptional student and the son of the well known merchant, **J. Bolender**. His many manly qualities and determined character speaks well for his future. He expects to complete his education by a university course.

Marion McLean, the only daughter of **Mr. and Mrs. George B. McLean**, is 18 years old and has taken the three year Modern Classical Course. She has been an industrious student and graduated with a creditable record. She has musical accomplishments. Her plans for the future are as yet unformed.

graduate of the Monroe High School Class of 1887. The groom is the son of **W. C. Gorham** and worthy of his companion whom he has won. They left on the 8:35 passenger train this morning for Chicago and will return about Wednesday. They will reside in this city and the groom will continue in charge of his father's farm east of this city.

June 28, 1895

Mr. and Mrs. Joe Barling and **Mr. and Mrs. Lou Barling** of Milwaukee are in the city to attend the funeral of **G. Van Wegenen**.

Invitations have been issued by **Mrs. Louise Barber** for the marriage of her daughter **Kathryn Barber** to Edgar **Merrill Griswald** on Wednesday, July 19 at the residence of **Mr. and Mrs. C. W. Twining**.

June 29, 1895

Milt Whitehead who went to Iowa to get married, returned with his bride last evening. They will reside with his father **Henry** several miles southwest of the city.

July 2, 1895

Mrs. Liddell, accompanied by her daughter and little son, went to Galena, Illinois today. Her husband and son rest in a cemetery near there and it is the first opportunity she has had of visiting the place, being seriously ill at the time.

July 6, 1895

Fred Baemke who was taken into custody on the grounds of insanity was examined and had a hearing before County Judge Dunwiddie yesterday afternoon and was released. He and his wife do not agree very well and this is thought to be the principal grounds of the case.

When he got back from Milwaukee he had a splendid collection of photos, trophies of his conquests in the city of beer. He was sitting on the curb in front of Toule and Horn's Saloon on Milwaukee Street yesterday afternoon in conversation with **Patrick Sweeney** when a runaway horse belonging to **John H. Gateley** came dashing down Franklin Street drawing the remnants of a cart with one wheel gone. A number of drays were standing near the corner and the runaway shied at them and took to the sidewalk. By its representation in the roster of the staff officers of the 1st Infantry, Wisconsin National Guard, Company H, Monroe City Guards is receiving due notice at Camp Douglas. The Milwaukee Sentinel this morning gives the following interesting review of the Monroe City Guards:

In December, 1832, some of the old soldiers aided by a plucky lot of young men, determined to organize a militia company which Governor Rusk had mustered into the 1st Infantry then commanded by the sturdy old veteran **W. B. Britton** who brought home the Eagle eight Wisconsin regiments at the close of the war. **Sam Lewis**, now vice president of the Bank of California in Los Angeles was elected captain and **Samuel P. Schadel** 1st Lieutenant. **Charles A. Young**, **Daniel A. Stearns** and **J. H. Durst** were in the ranks. Capt. Lewis was promoted to the rank of Major in 1861 and Colonel in 1893(?) but before going to the Pacific he resigned. The present commissioned officer is **Col. Schadel** who has been promoted through all the grades and though a comparatively young man is a veteran of the War of the Union and a thorough bred military man. Lt. Col. Young has likewise held every warrant and commission including his present rank from private. He is a brother of "**Art**" **Young** the well known artist and newspaper columnist. Major Daniel A. Stearns commands the 2nd Battalion and is an enthusiastic guardsman and is also Captain J. H. Durst, the regiment adjutant. All the above named officers of the 1st Infantry were originally in the ranks of the Monroe Guards and have gained their present positions by regular promotion and faithful service. **Surgeon General Byers** also known as "Irrepressible" Byers also lives in Monroe. He helped to organize the company that has been so favored in the field of the 1st, was an assistant surgeon when Col. Britton was commanding, served as surgeon from 1885 until January 1st, when Gov. Upham made him Surgeon General of the Badger State.

It will be under the auspices of the Oddfellows.

August 17, 1895

August 19, 1895

It is with a keen sense of sorrow that the very critical nature of the sickness of **Joseph T. Bridge** became known a few days ago and the public were not prepared for the end that so quickly followed. Death came to his home at 5:00 this morning and a good man, highly esteemed is no more. The disease which cut him down so early in life was cancer of the stomach. There was little evidence of the disease which was lurking in his system. Last February he became troubled and though he concealed it as much as possible the awful traces of the ailment that was undermining his health and making life miserable for him became noticeable on his robust countenance. He sought relief at Excelsior Springs, Missouri, but finding it was taxing his strength rather than bringing relief he returned home after a short stay, reaching home in July. He failed gradually and was obliged to take to his bed but he did not give up to the end that came so fast. His death has created widespread sorrow. He was a man of strict integrity and he was highly esteemed in the city he called his home. While he was a quiet, retiring man, he was one of the most genial and approachable men in the city. He never aspired to prominence or public favor and was elected to the city council against his will. He was a Republican in politics but radical on no subject but of good judgment and even temper. Mr. and Mrs. Bengston left at 3:00 this afternoon to drive across the country to Freeport where the groom has prepared a home for them at 161 Harlem Avenue where they will reside. **Miss Sophie Hoehn** and **Ed Kundert** accompanied them as far as Orangeville. The groom holds a responsible position in the jewelry store in Freeport and is said to be a man of sterling worth.

October 1, 1895

Wm. Seltzer returned last evening from a three month visit at the house of his birth in Switzerland. He was accompanied by a brother who resides in Milwaukee and their visit was a source of great joy to an aged mother who had not seen her sons for many years. He reports a fine time.

October 2, 1895

Mr. and Mrs. Fred Buehler mourn the loss of their three month old child **Sully**. The little one died last night of cholera infantum. The funeral will be held at 10:00 tomorrow morning from the house.

Death came to **Mrs. Julia Hess** wife of **Thomas Hess** at 8:45 last evening. She had been ill since Friday with bowel trouble and her death is a great surprise for her friends. She was a faithful wife, a loving mother and a good neighbor and her death is a great loss to her husband who is left with two small children, one 16 years and the other 3 years of age. The funeral will be held at 2:00 tomorrow afternoon from the German Methodist Church.

October 3, 1895

At midnight last night the little son of **L. Barnett** who resides on Racine Street was relieved of his sufferings by death. He was ill three weeks with diphtheria and was six years of age. Rabbi Bolton held a brief service this morning and the remains were shipped on the Illinois Central to Dubuque for interment.

October 4, 1895

John B. Perry died last night at his home in Albany. He was failing in health for some time and his death was due to general breaking up. He was 83 years of age and in his death Green County loses a pioneer. He was widely known and long identified with the Village of Albany. He was born in Elizabethtown, New Jersey December 11, 1812. He, in 1838, came west to Dundee, Illinois and engaged in teaching school. In December, 1839 he came to Green County and engaged in mining lead ore in the township of Exeter. In 1842 he was appointed justice of the peace by Governor Doty. He remained in Exeter until 1844 when he returned to Dundee and engaged in farming. In December, 1846 he returned to Green County and went to teaching in Albany. In the fall of 1847 he came to Monroe and read law at the office of J. W. Stewart until the fall of 1848 and then again he went to Exeter and was elected justice of the peace in 1849. In 1850 he was elected town clerk and the same year he was appointed U.S. Marshall to take the census in Green County. In 1851 he removed to Albany and in 1852 was elected justice in that town and has held that office continually since that time. He has held other offices of trust. He served as town clerk and deputy town clerk 18 years. He was county commissioner two years, notary public for 12 years and school director for 15 years. In 1881 he was sergeant at arms of the assembly in Madison. In 1883 he acted as attorney for the Village of Albany and secured the incorporation of the village. He was admitted to the bar of this city in 1854. He was married in 1840 to **Amy M. Kellogg** and seven children were the result of the union. The funeral will be held Sunday.

October 7, 1895

October 8, 1895

Yesterday afternoon at 5:00 death came to **A. B. Fitch** at his home on the Beloit Road. He had been ill for the past two years with a complication of ailments and at the time of his death was 65 years old. He had been a resident of Monroe for twenty years and his life had been an honorable one. A wife and four grown up children remain to mourn his loss. The funeral will be held tomorrow afternoon at 2:00 from the home.

October 14, 1895

Saturday night **Mrs. Emma Hoesley** sank into peaceful slumbers at her home on South Emerson Street. The summons came at 12:00 and her father and friends were at her side. She was a sufferer of slow consumption and all through her illness she showed great ambition to overcome it. She was the only daughter of **David Stucky** and at the time of her death was 30 years, 8 months and 12 days of age. In December of 1890 she was married to **Casper Hoesley** of this city who survives her. The funeral was held at 2:00 this afternoon from St. John's Evangelical church with Rev. Paul A. Schuh officiating. There was a large attendance and many followed her remains to the cemetery where they were laid to rest beside a mother who has passed this life. The pall bearers were **W. F. Truckenbrod, Albert Hoehn, Charles Keebner, Henry Hoesley, Ed Kundert** and **Ed Lenz**.

October 16, 1895

The report of a horrible death near New Glarus has just reached us. **Samuel Hoesley**, a farmer, started out with a shotgun to shoot crows. A short time after he had gone, the report of a gun was heard by members of the family, though the report sounded as though the gun had been overloaded so they started out to find Mr. Hoesley to warn him against loading the gun heavy. After going along a distance they were horrified to find the body of Mr. Hoesley with the head terribly torn and mangled, the whole top of the head above the eye being blown to fragments. A coroner's jury was at once summoned which brought in a verdict of accidental death. He was a member of A.O.U.W.

Mrs. S. B. Mack received a telegram today from **Mrs. J. P. Preston** of San Diego, California stating the "Mr. Preston is dead. Have found the body today." No other information was received. The message was a shock to his niece Mrs. Mack and his friends in Monroe will be pained to learn of his death.

October 17, 1895

Married, at Milwaukee on Tuesday evening at 8:00 at the residence of the bride's parents at 1012 Lloyd Street, **Minnie Reibau** to **Otto Tschudy**, by Rev. George Ulrig of the Evangelical Trinity Church. The groom is the son of **Mr. and Mrs. J. J. Tschudy, Sr.**, and is a young man well known and well liked here. Mr. and Mrs. Tschudy will arrive in this city tomorrow evening and will be at home to their friends after November 1 at their home on Lybrand Street between Liberty and Payne Streets.

Death relieved **Harrison King** at 12:45 today. Some time ago, he suffered a stroke of paralysis and since then has been lingering on the border of life and death. He was 81 years of age and had spent almost one half of his life in Green County coming here from Ohio. For many years he engaged in farming in Clarno and he disposed of his farm

and removed to Monroe fifteen years ago. Ten years ago while making soap, he splashed his face and this deprived him of the use of one eye. He was a member of the Masonic lodge and the M.E. Church. Besides a wife who can survive him but a few days, a son **Harvey King** remains of the family.

After ailing for some time, death came to **John Gettings, Sr.**, at his house west of the city at 6:00 this morning. He suffered from kidney trouble for many years. He was born in the County of Sligo, Ireland 83 years ago. He came to Green County in 1854 and located on a farm in the township of Jordan. From there he came to Monroe and engaged in the meat market business for 20 years, retiring a few years ago, his son continuing the business. He departed this life with a record of industry and honor. A wife and four grown up children, one son and three daughters, survive.

Mrs. Maria Brown died at her house in Jordan yesterday. She was troubled with dropsy and was 70 years of age. She was the wife of **Douglas Brown** and was a resident of this county for 49 years. Seven children survive her among them are **Mrs. John Thomas** of Winslow, and **Thorm Crago** of this city. The funeral was held this morning and interment was in the Kelly Cemetery at Cadiz.

October 18, 1895

At 7:00 last evening at the home of **Mr. and Mrs. Charles Grochowsky**, their daughter **Ida** was married to **John Schneider** by Rev. Paul A. Schuh of St. John's Evangelical Church. The only guests present were the members of the families of the bride and groom. The bride and groom have always lived in Monroe. The groom is employed in the tailoring firm of **Henry Hoehn** and is an industrious young man of good habits. The young couple will reside in Monroe.

October 21, 1895

A newly made mound in Greenwood Cemetery marks the last resting place of **Mr. and Mrs. Harrison King**. Companions of long life were companions in death. Mr. King died last Thursday and Mrs. King followed at 6:00 Saturday evening. The funeral services were held from the home at 2:00 yesterday afternoon and they were laid to rest side by side. Rev. I. F. Nazum of the M.E. Church officiated. After leaving the house the remains were in charge of the Masons who were present in a body and laid them to rest with Masonic honors in the presence of a large number of friends. A son was their only immediate mourner. The pall bearers were **George Churchill, J. B. Treat, John Connery, A. F. Glascott, Daniel Howver** and **Peter Gnagi**. Mrs. King had been in poor health for some time and it was little thought that she would outlive her husband even for so brief a period. But when he was stricken with paralysis she was determined to administer to him the same loving care that was bestowed upon her in her illness. The task was more than her frail constitution could bear. She broke down under the great weight. Days passed and her life was but a fluttering spark. Accompanying the casket were **Mr. and Mrs. Charles Hirsig** of Cheyenne, **Will Hirsig** of Casey, Illinois and **John Hirsig** of Monticello. The deceased was 21 years of age and what makes her untimely demise seem more cruel is the fact that she was engaged to be married to **George Montgomery**, a worthy young man of Cheyenne, Wyoming, but she was taken ill with inflammation of the bowels and death claimed her. The funeral service will be held at 2:00 tomorrow afternoon at St. John's Evangelical Church.

Mrs. Grant Rose of Richland Center has been visiting her cousin in the city, **Mrs. Henry Thorp**.

Peter Burk went to Madison yesterday evening to attend the funeral of a little niece which was held there in the afternoon.

About 45 guests were present. The bride is a sister of **Soloman Lefitan**, the well known New Glarus merchant. The groom is the senior partner of the Chicago store which has become a very attractive place for the short time it has been established in Monroe. The happy couple will reside here.

November 21, 1895

Married, last evening at 8:00 at the residence of **Mr. and Mrs. Henry Hoesley**, in the First Ward, by Rev. Paul A. Schuh of St. John's Evangelical Church, **Louise Deischer** to **Jacob Hoesley**. The bride is the daughter of **Mrs. Louise Heinzelman** of Clarno. The groom has recently gone into business for himself at the corner of Jefferson and Racine Streets and is a young man who commands the esteem and respect of all who know him.

Married, last evening by Rev. I. F. Nazum at the residence of the bride's sister, **Mrs. Fred C. Wenger, Rosetta H. Noble** of Mineral Point to **John Klockner** of this city.

Married, at the M.E. parsonage yesterday by Rev. I. F. Nazum, **Clare Johnson** and **William McDonald**, both of Wolford.

Married, at 10:00 this morning at the home of **Mrs. Amelia Tschudy** at New Glarus, by Rev. J. T. Etter of New Glarus, **Fannie Tschudy** to **Jacob Urban**.

November 26, 1895

The horrible accident on Sunday may leave **Mack Kelly** a permanent cripple. It is now thought he will lose the use of his left hand, so severely was the burn as to shrink the cords and the muscles which rolled off like a glove. His wounds irritated rawness where the flesh was exposed to the flames and have been bound with cotton and he is kept constantly under the influence of opiates to relieve him of suffering that resulted from the accident which might have cost him his life. Using gasoline when he thought he had kerosene was a fatal mistake. It was followed by the good fortune of having an open stairwell to the room below the laundry used as a bottling works. After the explosion when he discovered he was in flames he rushed down the stairs screaming for water. His burning clothes set afire two barrels of water as he passed them and **Otto Leunenberger** who happened to be there and turned the hose from the water onto him and this alone saved him from the fate of the flames. When the flames were put out the victim was overcome by exhaustion and his clothing so burned and scorched that it would not hold together. Mr. Kelly is a member of the Royal Arcarium and will receive the sick benefits and aid of the lodge during the time he is laid up. A

week ago he escaped from a similar accident while engaged in molding at the foundry. His clothes got on fire and it was through the aid of fellow workers that he escaped injury.

November 27, 1895

William Gavigan of the township of Adams perished with Monday night's storm. He was found yesterday afternoon frozen stiff in a field with nothing but his boots protruding from the snow. Monday he attended a grubbing bee at the home of **Rube Garrison**. Returning home in the evening, he rode as far as Kelly's Corner with **Michael Monohan** and left to go across the field to his house a short distance away. It seems he had not gone far for but 15 rods away is where his lifeless body was found almost 36 hours later. An over supply of liquor was no doubt the cause of his death. He was about 70 years of age and found much comfort in intoxicants. It is supposed he became too weak to reach home. He lay down and froze to death. He was an upright citizen and had an only fault and the manner in which he died is much regretted. A wife and seven children in good circumstances survive. The remains will be buried at Puddledock tomorrow.

December 2, 1895

Death followed shortly after the announcement of the illness of **August Schuetze** was made known Saturday. He began to fail rapidly until 7:00 in the evening when he sank into a peaceful sleep. He had been ill but a week with what was thought to be a cold. **August Frederick Schuetze** was one of Monroe's oldest citizens. He was born Jan. 27, 1807 in Lychen, Prussia. He was married march 22, 1832(?) to **Miss Juliana Ploetz**. In 1863 they came to America and located at Stevens Point. In August of 1866 they removed to Monroe and resided here until his death. He was 88 years, 10 months and 3 days of age. His wife preceded him to the land of rest ten years ago. In 1882 in this city they celebrated their Golden Wedding Anniversary and few occasions of this kind were more notable. Mr. Schuetze has stood aside to see death enter the family; not only his own but that of his children and grandchildren and his death will be deeply mourned by four children, 26 grandchildren and ten great grandchildren. He was one of those good old men who made the world a better place by living in it by his kindly words and aid to the less fortunate. He was a man remarkably well preserved in his mental powers for one of his years and was one who suffered very little illness. The funeral will be held at 2:00 Tuesday afternoon from St. John's Evangelical Church and Rev. Paul A. Schuh will officiate.

December 5, 1895

Miss Josie Barker and **Treat Wells** thought they would spring a surprise on their friends last evening and drove to the M.E. parsonage and were married by Rev. I. F. Nazum. No one was present outside of the minister's family. After the marriage Mr. and Mrs. Wells went to the home of the groom's parents where supper was served to the immediate relatives. The groom is the son of **Mr. and Mrs. Thomas B. Wells** and is engaged with his father in the boot and shoe business on the east side of the square. He showed up this morning as if nothing had happened and many will now know of it until they read it in these columns.

December 9, 1895

That venerable old citizen of Green County, **Jacob L. Roderick**, is no more. His life went out calmly at 5:00 Sunday morning. He had been in feeble health for the past summer and began to fail. He was one of the best known citizens

in the county and his death brings sorrow to the hearts of many friends. For forty years Mr. Roderick has been a resident of Green County, coming here in the spring of 1843(?), locating on a farm in the township of Jefferson, residing there until he removed to this city in the fall of 1886. He was born May 27, 1829 in Fayette Co., Pa. He married **Elizabeth Newman** on Dec. 25, 1851. For many years he was one of the leading men in the township where he resided. For almost 15 years, he was the town chairman. He was a staunch Democrat and took a great interest in politics and national matters. He was a shining mark of manhood and by his honesty and integrity was the architect of his own fortune. He reared a large family and as the result of his life work he left them well provided for. A post mortem examination revealed that he was a sufferer of (*illegible word*) consumption. During the entire time he was a resident of Green County he was a member of the Baptist Church of Juda. It is of his own request that he will be buried there tomorrow. Funeral services will be held at his late home at 9:00 tomorrow morning and then at the Juda Baptist Church at 11:00. The interment will be in the family resting place in the little church yard. A wife, six daughters and three sons remain to mourn his loss.

In the old home where she had resided for so many years, death came to **Mrs. Hannah G. Smock** at an early hour this morning. She had lived to the ripe old age of 74 years and 21 days. She was the wife of **John Smock** who passed this life July 22, 1889. Since then she has been making her home with her daughter **Mrs. F. D. Jeffery** on the homestead in the township of Clarno. For the past year she has been a sufferer from lung trouble. A son **Frank** also survives.

December 9, 1895

Married, at the M.E. parsonage, at Oregon, on Sunday, Dec. 1, by Rev. W. C.(?) Nazum, **Miss Erme Roe** to **Don Bacon**. Mr. Bacon is the son of **Mrs. Emma Bacon** of this city. He is in the employ of parties in Oregon and the happy couple will doubtless make their home there.

December 12, 1895

The announcement of the marriage of **Adam Blumer, Jr.**, to **Lena Schmidt** will be something of a surprise to their best of friends. It occurred at 7:30 this morning at St. John's Evangelical Church by Rev. Paul A. Schuh. They were attended by **Miss Lizzie Schmidt**, sister of the bride and **Fred J. Blumer**, brother of the groom. After the ceremony the wedding party was conveyed to the Illinois Central Depot and Mr. and Mrs. Blumer left for Elgin, Illinois. The marriage was kept quiet and the groom did not even let his friends in the fire department know it and they propose to let him and his bride lead the grand march at the Christmas dance. The bride has always made her home in this city. Adam is the son of the proprietor of the Monroe Brewery and is an honorable, ambitious and capable young man.

December 14, 1895

On Saturday, Dec. 21 at the home of **Mr. and Mrs. Willis Ludlow** in this city will occur the marriage of **Miss Kathryn Frances Meeker** to **Clarence Sidney Funk**. The cards were issued by **Mrs. Harriett Meeker**, mother of the bride, this morning. It is a great surprise to the bride's many friends as it was the only announcement they had of

the marriage. Mr. Funk is employed by Warder, Bushnell and Glessner Co., of Chicago.
