**April 6, 1899**

**Mrs. Sabilla Blasé Bolinger**, wife of **Jacob Bolinger** of Monroe, died today after suffering two or three years from cancer. She was born in Switzerland on June 1, (*year partially illegible, 18\*7*). The funeral was held Monday afternoon at 1:00 and the interment will be in the cemetery west of Junction House.

Mrs. **J. M. Chenowith** is receiving a visit from her sister **Mrs. A. Tuthill**, of Green Lake Co.

**Mr. and Mrs. W. P. Jackson** and children arrived here last evening from Cleveland, Ohio for a visit to Mrs. Jackson, parents of **Mrs. J. Bolender**.

**Mrs. E. O. Flint**, who has been here on a visit to her daughter, **Mrs. H. W. Hyde**, returned to Chicago today.

**Benjamin F. Wolf**, the Clarno merchant who was injured by being thrown from a platform of the Illinois Central a week ago last Tuesday, died at 3:00 Thursday afternoon at his home in Clarno. Since his right leg was amputated below the knee, his recovery was expected but the great loss of blood before the amputation, together with the severe shock to his nervous system, proved to be a combination that he, with his advanced age, could not overcome. The amputation was not made until 14 hours after the accident which is not the proper attention that a man injured as he was should receive. He lost blood all that time and the surgery left him in a very weakened condition. He was well known and had the highest esteem of his friends. He and the wife who survive him have been residents of Clarno for 14 years. For a number of years he was postmaster, looking after the mails in connection with his store. He was 63.

The funeral of **Benjamin F. Wolf** was held at Clarno this morning and at 10:30 from the Amity Church at Orangeville. Interment was at the cemetery at Orangeville. The deceased was born in Union Co., Pa., April 2, 1838. He was married 35 years ago to **Mary Herbert** of Orangeville. She alone survives him.

**Miss Emma Miller**, daughter of **Mrs. Anton Miller**, will be taken to Milwaukee tomorrow to have an operation on a tumor.

**Mr. and Mrs. Ernest Baskin** of the 3rd Ward have a very sick baby.

**John Ruch**(?) of Clarno was taken to St. Francis Hospital in Freeport and operated on Saturday, March 25 and died Friday at 2:10 pm. **John Schertenlieb** received the telegram announcing his death. The body will arrive here this evening and be taken to the home of Mr. Schertenlieb. Mr. Ruch was 35 and leaves a wife who is in a delicate condition and two children. e was a cheese maker and made cheese at the Tinim factory in Richland and became well known. His wife and a brother **Arnold** were with him at Freeport. They are the only relatives there. Mr. Ruch got along well after the operation but Tuesday brought a change in his condition and he grew rapidly worse. Mr. Schertenlieb is a close friend of the family.

Sunday at high noon at the parsonage of the M.E. Church in Argyle **Miss Amida Sisson** of Argyle and **H. O. Kelly** of this city were married by Rev. Arthur C. Vaughn. Miss **Mandie**(?) **DeVoc** was bridesmaid and **D. S. DeNeen** was best man. No one but the attendants were present. Following the ceremony a wedding dinner was served at the residence of the bride's parents, **W. A. Sisson**. Mr. Kelly and his wife arrived here this morning to finish the arrangements on their home on the Payne block where a finely furnished suite of rooms awaited them. The groom is a Monroe boy who has been climbing the ladder of success aided alone by the merits of his own efforts. Long ago when he was still a lad and labored at the key as an apprentice in telegraphy at the Illinois Central Depot, the company quickly recognized his worth. He was given a trial and promotion came rapidly until the company entrusted to him all

the affairs of the office here and a better man could not be found for it.

Married, on Sunday, at 2:30 pm by Rev. C. E. Varney at the parsonage of the Universalist Church, **Miss Ella B. Ballard** and **Theodore A. Thurston**, both of Argyle. The groom is the son of **Richard Thurston** of Argyle and is engaged in the lumber business there.

**Miss Maggie Flanigan**, daughter of **Michael Flanigan** of Farmers Grove, and **John McDonald**, a farmer of South Wayne, were married at St. Joseph Church at Argyle at 9:00 Wednesday by Rev. Dowling.

**Mrs. Anna Morehead**, wife of **John Morehead**, died Thursday morning at 1:50 after a lingering illness. The funeral will be held Saturday afternoon at 2:00. Mrs. Morehead's maiden name was **Anna Irvin**. She was born in Crawford Co., Pa., on Jan. 5, 1833(?) and married John Morehead in the fall of 1860. They came to Green County immediately after their marriage and settled in Clarno Township. Here Mr. Morehead owned a fine farm. They lived there until they removed to Monroe to occupy a comfortable home that was built for them on East Payne St. Mrs. Morehead was stricken with paralysis in July of 1894 and has been a patient sufferer until her death. One child was born to Mr. and Mrs. Morehead but died in infancy.

Many Monroe friends were deeply grieved to learn of the death of **Mrs. Jacob Baumgartner** which occurred at her home in Long Hollow, Washington Twp., at 4:00 Saturday morning. A week ago she gave birth to a child and soon afterwards both mother and child had the measles. The sickness of the mother developed into pneumonia. She was a daughter of the late **L. T. Clayton** and was a member of the Center M.E. Church. Two years ago the death of a daughter was a terrible blow to the family and to the husband and three children with the baby who survives goes out the greatest sympathy of the community.

**Charles Hart**, a pioneer hotel man of this city, died Wednesday at the home of his daughter **Mr. E. E. Hough** at Davis Junction. Mr. Hart was born in Carlisle, England in 1818 and with his brothers came to New York in 1835. In 1840 he married **Emily Cole** of Chatauqua, New York, and soon removed west to Monroe. He built and kept the first hotel in Monroe and assisted in building the court house in Janesville. Among his papers are deeds of land where the city of Janesville now stands, signed by President James K. Polk and a commission as lieutenant in the army during the Blackhawk War signed by Gov. Dodge. His wife and six children survive. They are: **A. R. Hart** of Clinton, Iowa; **Mrs. S. E. Pells**(?) of Seattle, Washington; **Charles and William** of Minneapolis; **Emma** of Davis Junction; and **Eugene** of Madison. The funeral services were held at Rockton, in charge of the Masonic fraternity of which the deceased was a member. Rev. E. D. Hector of the M.E. Church of Monroe officiated. The interment was at Rockton Cemetery.

Probate Matters that came before Judge Becker for March and April:

In the matter of the estate of **James W. Spencer, Jr.**, late of Brodhead, administration was granted to the widow **Flora Spencer**. The estate exclusive of the home is valued at about \$3,500. The deceased left a widow and one son surviving him.

In the matter of the last will and testament of **J. Jacob Tschudy, Sr.**, late of Monroe, his will was admitted to probate and **J. Jacob Tschudy** and **Fridolan Tschudy** were appointed executors. The estate is valued at about \$20,000. The estate is to be divided among the nine children, share and share alike.

In the matter of the estate of **Syver Holverson**, late of Adams Twp., **Thomas N. Thompson** was appointed administrator. The estate is valued at about \$4,200. The deceased left surviving him four sons and two daughters.

The last will and testament of **Jacob Weismuller** was admitted to probate and his son **Edward** was appointed administrator. The estate in Wisconsin is valued at about \$13,000. He also owns real estate in Iowa. The value of that was not given. The deceased leaves a widow and two daughters and five sons and three grandchildren of a deceased daughter. By the terms of the will he gives to two of his grandchildren \$150 each and to one grandchild \$200; to his daughter **Louisa** \$500; to his widow **Elizabeth Weismuller** one third of the real and personal property in Wisconsin; to his daughter **Emma** and to his five sons one sixth of two thirds of the property in this state. The land in Iowa is divided by his five sons, share and share alike.

In the matter of the estate of **Inger Erickson**, late of York Twp., administration was granted to **Wm. Owens**. The estate is valued at \$1,000. The deceased left three sons and two daughters and four grandchildren of a deceased daughter.

In the matter of the estate of **Ruth Becker**, the sale of one fifth interest in the real estate located in the township of Jordan was given to **John Hanson** for the sum of \$550, was confirmed.

**Nancy Newman** of Decatur Twp., was declared incompetent and **John A. Burt** was appointed guardian.

The last will and testament of **Jacob H. Wessel**, late of Albany Twp., was admitted to probate and **Thomas Gravenor** appointed executor. The estate is valued at about \$800. He left no widow or children. He gave his estate to his two brothers **Peter and Andrew Wessel**.

In the matter of the estate of **Francis Laroque**, final judgment was rendered, distributing \$471.05 in the hands of the executor to six heirs at law in equal shares.

In the matter of the estate of **Stephenson D. Black** late of Clarno Twp., final judgment was rendered giving personal property of \$129.33 and 53 2/3 acres of land and one lot in the village of Browntown to one son and two daughters in equal shares.

In the matter of the estate of **Henry Wilbur**, deceased, the final act of the administrator was approved and judgment rendered assigning the real estate to six children in common subject to the unassigned dower and homestead rights of the widow **Mary Wilber**.

In the matter of the estate of **Christian Evanson**, deceased, final judgment was rendered assigning \$3,136.15 to **Carle Evanson**, the widow and four minor children, in common, subject to the unassigned dower rights of Carle Evanson, the widow.

In the matter of the estate of **Hibbard Peebles**, late of York Township, administration was granted. The deceased leaves a widow and one son. Personal property was valued at \$1,100.

In the matter of the estate of **Simon Hanson**, late of Adams Township, administration was granted to **Pandy Hanson**. The estate is valued at \$6,000. He leaves surviving a widow and ten children.

In the matter of the estate of **Louise Nix**, the final account of the executor **Wm. Zilner**, was approved and the amount of \$6,616.18 assigned to seven legatees in accordance to the will, one receiving \$25 and the others each \$1,008.30.

In the matter of the estate of **Mary Mohns**, final judgment was rendered assigning the sum of \$2,407.19 to nine heirs each receiving \$267.45.

In the matter of the estate of **Joseph Green**, final judgment was rendered assigning the sum of \$10,215.15 to eight children and five grandchildren, the children each receiving \$1,021.41; two grandchildren received \$510.55 each; and three grandchildren of a deceased son each (*the rest of this line is totally illegible.*)

In the matter of the estate of **W. S. Peckham**, the final account of the executors was approved and the sum of \$8,306 was assigned. \$5,094 went in trust to his daughter and after her death to be equally divided among her children; the residue to **E. M. Peckham**, **G. H. Turner** and the children of G. H. Turner. The real estate consisted of five houses in Albany which were assigned to the widow E. M. Peckham. The (*illegible word*) of the real estate was assigned to **George E. Peckham** a son (*illegible word*) with an annuity of \$216 per year to the widow.

The last will and testament of **W. W. Wright**, late of Monroe, was admitted to probate and **Lucy R. Wright** was appointed executor. By terms of the will he bequeathed his estate to his wife. He left surviving him a wife and one son and two daughters. The personal estate is valued at about \$(*illegible, either 3,000 or 5,000*).

In the matter of the will of **Sylvia M. Clark**, late of Attica, the will was signed by three witnesses but none of the witnesses signed in the presence of each other and probate was denied the will not being lawfully executed.

In the matter of the will of **J. R. Fleek**, late of Decatur Twp., **Mrs. Dawson**, a daughter, objected to the probate of said will and gave notice of contest. The matter was adjourned to May 4.

In the matter of the estate of **Knut Thompson**, late of York Twp., administration was granted to **Ole K. Thompson**, a son. The personal property is valued at \$17,000 and the real estate at \$9,000. The deceased left surviving him **Betsey Thompson**, his wife, and nine children, four sons and five daughters.

In the matter of the estates of **Daniel Keen**, **Hebron Johnson**, and **Christine Loertscher**, judgments of no claims were entered.

In the matter of the estate of **Thomas J. Campbell**, the claim of **Louisa Campbell**, a daughter, for services to the amount of \$1,093 was objected to by the administrator, **J. H. Durst**. The hearing was set for April 19.

#### April 29, 1899

#### April, 1899

The first marriage to take place at St. Joseph Church at Argyle was on Sunday, April 10 when **Agnes Menahan** of Jordan married **Michael Monaghan** of Argyle, Rev. Dowling officiated.

**Sheriff Gardner** went to Brodhead to see his uncle, **C. J. Gardner** who is very sick, lingering at the point of death. He came here from Michigan a year ago and has been sick a long time.

**Mrs. Wm. J. Bossingham**, residing two miles southeast of Oregon, committed suicide by cutting her throat with a razor as she lay in bed with her little daughter about 11:00 pm last Friday. The loss of a little babe a few months ago and poor health affected her mind. She was about 35 years old and leaves a husband and four children.

**Mrs. Frances Dunlavy** was before Judge J. M. Becker today and was committed to Mendota Hospital for treatment she having been judged insane at a prior hearing.

#### April 20, 1899

**Miss Emma Miller** was removed of a large cancerous tumor at St. Mary's Hospital in Milwaukee and died Sunday as a result of the operation. From the time the operation was performed it was hardly expected she would survive. The operation had been resorted to as the only hope of saving her life. She herself realized it was her only chance and was anxious to have the operation. She was born in Monroe and lived her all her life. She was 38(?) years of age and besides her mother leaves several brothers and sisters. She was of a frail constitution but seldom was sick and her ailment had never caused any illness except that her health was being undermined. The funeral was held Wednesday at 10:00 from St. John's Evangelical Church and by Rev. Paul A. Schuh.

**Mrs. Barbara Somers**, wife of **Jacob Somers**, died at her home on West Washington St., at 8:10 am Monday. She had suffered from cancer for nearly a year and a half. She was a native of Switzerland and she and her husband have made Monroe their home for many years. She was 55 years of age. A husband and one daughter survive, **Mrs. Julius Beester**(?) Beesier(?) of this city. Funeral services were held at St. John's Evangelical Church Wednesday at 2:00 by Rev. Paul A. Schuh.

**Miss Anna Matzke**, 20, died at her home in the Township of Jefferson at 5:00 Saturday afternoon after a few months illness. She was the daughter of **Christian F. Matzke**. The funeral will be held from the house at 10:00 tomorrow and at 11:00 from the German Church at Juda. The interment will be in the cemetery one and a half miles north of Juda.

Monroe relatives today were notified of the death of **Albert A. Fayette** in Chicago Sunday afternoon at 2:00. He suffered from consumption and had been sick for several years past. He was born in Albany, Green County, and was

50 years of age. Two years ago he spent the summer here for his health. He had also been in New Mexico but had not been relieved. He leaves a wife and seven children. He was a brother to **Mrs. B. S. Kerr** of this city who has been in Chicago for a few weeks.

Married, at the residence of the bride's parents, **Mr. and Mrs. John Luchsinger** shortly before noon Tuesday by Rev. J. C. Brandel of Madison, **Ella Luchsinger** of this city to **Edward Stauffacher** of St. Paul. The service was in German. Following the ceremony a wedding breakfast was served. The bride wore a becoming tailored suit of brown broadcloth. She is the eldest daughter of the household and will be greatly missed at home. She was best known at Emmanuel Evangelical church with which she united when quite young and where she has been a willing and active worker. She is a graduate of Monroe High School. The groom is the son of **Mr. and Mrs. Henry Stauffacher** of Sylvester Twp., and is a prosperous businessman of St. Paul, where he is engaged in the cheese commission business.

Married, at the residence of the bride, at 3:30 this afternoon, **Lena Steinman**, daughter of **Mr. and Mrs. J. C. Steinman** of Monticello, to **Herman Karlen** of Washington Twp. The wedding was one of the largest that ever took place in Monticello, nearly 150 invitations being issued.

**Thomas Maher** of the township of Exeter, four miles northeast of Monticello, was making some repairs on the tower of a windmill when the wheel began to revolve, throwing him to the ground, a distance of fifty feet. He received internal injuries from which he died. He was 50 years of age.

**Mrs. A. C. Tuthill**, who was here on a visit to her sister **Mrs. E. L. Chenowith**, returned to her home at Marquette this morning.

**August Splinter** of Cadiz who was drunk here and was not home all last week, put in his appearance yesterday and there was a hot time at the old farm. Two officers were sent for and August Splinter was brought to town and locked up. He was put under \$300 bond to keep the peace and sent home. His wife threatens to apply for divorce if he does not behave himself.

**Mrs. John McDonald** and her sister **Miss Joanna Flanigan** arrived here from South Wayne this morning.

**Mrs. Joseph Spangler** who has been on a visit to her father, **Wm. Rean(?)**, left for her home at Rolfe, Iowa, this afternoon.

**Mrs. Amelia Zimmerman**, wife of **Conrad Zimmerman**, died suddenly at her home on East Washington Street at 6:20 Wednesday morning. Another child, a son, is now sick and in a serious condition. Two of the deaths occurred in March and April, last year, and the other death was in April of this year.

**Martin Disch**, an old resident of New Glarus, died Friday afternoon after an illness of several months. He was 76 years of age. His daughter, **Mrs. Fred Hefty**, of this city, went to New Glarus today to attend the funeral which will be held Sunday.

At Beloit **Mrs. Toney Baumgard**, by mistake, bathed the chest of her infant with carbolic acid instead of camphorated oil. The child will probably die.

The funeral of the late **Reuben Holcomb** was held Sunday at 9:30 from the home of his son **Ernest Holcomb** in the township of Adams. It was intended to have the service at the graveside at Greenwood Cemetery but it was raining so heavily by that time and the service was brief.

Included in the list of unknowns among the soldiers who served their country in the recent struggle and of whom there is no activity on the record of living or dead is the name **Fred Hefty** of this city. Relatives have made every effort to locate him or learn his fate in case he had fallen on the field of battle but have met with no success. Up to a year ago, he had served five years with the 4th U.S. Cavalry. He was a sergeant and his family is about certain that he would not have left the army after five years. They have tried to locate his old regiment of cavalry but only know that a portion of it went to Manila. The missing soldier is 33(?) years of age and the youngest brother of **J. H. Durst**, cashier of the Citizen's Bank and **Capt. M. C. Durst** of this city. Years ago his father, **Sebastian Durst** of Albany, lived here and the young man worked for the late firm of Glascott and Briggs. In April of 1887, over 12 years ago, he left to get a chance to see some of the country. The last the family heard from him he had joined the 4th U.S. Cavalry. A few years ago, **Mr. and Mrs. J. B. Treat** visited Californian and they went to Presidio, the government military station near San Francisco and met the young man who was on duty there. Since then, nothing has been heard of him.

The coroner's inquest in the case of **G. J. Bender** who died suddenly while at work in a field at his home in the township of Clarno adjourned Monday afternoon after viewing the remains. A verdict of death by natural causes will doubtless be returned. A post mortem examination revealed that death was caused by hemorrhage of the lungs, the lungs being found in the worst possible condition. It was just a week ago that she was taken ill which developed into peritonitis which had been brought on by liver trouble of long standing. Burnham** of Sackett's Harbor, N.Y., remaining there until May 8, 1845 when he was admitted to all of the courts of the state at Oswego. He came west in the fall of the same year locating at Janesville where he at once engaged in his profession. In 1862 he was elected district attorney of Rock County and served in this office until 1867. In 1882 he was elected to the Circuit judgeship of the 12th Judicial Circuit and succeeded himself as such since that time this being his third term. The 12th Judicial Circuit embraces Green County, Rock County and Jefferson County and has had two judges, the **Hon. H. S. Conger** and **Hon. John R. Bennett**. On Nov. 28, 1844 at Hounsfield, Jefferson Co., N.Y. he married **Elsie L. Halloway** whose sweet and gentle influences ever tended to lead him in the pleasant paths of life. She died May 18, 1893. In 1859 he was a delegate to the convention which nominated Abraham Lincoln. He was a modest and unassuming man of quick sensibilities. He leaves to mourn his loss two adopted daughters **Misses Kittie and Minnie**; a brother, **D. D. Bennett** and two sisters **Mrs. James S. McGowan** and **Mrs. L. L. Williams** all of Janesville.
