January 3, 1899

J. Jacob Tschudy, Sr., one of Green County's best known citizens, died at 4:00 this morning as a result of a stroke of paralysis that he suffered Friday night at 10:00. The stroke was on his right side, affecting his hearing and speech. It left him able to speak but it was difficult to understand him. His condition remained unchanged until Sunday morning with he became unconscious and continued to fail until the end came. He was one of the oldest men who were prominent in Green County in the early days. He was born in the Canton of Glarus, Switzerland on June 26, 1836 which made him 73 years of age. There he received his early education in the schools. In 1846(?) he came to Wisconsin being sent by the emigration association of the Canton of Glarus as assistant leader of the Swiss colony which was founded in 1845. He came to look after the wants and to assist the sick and the poor. In 1854 he resigned this office and became a merchant in New Glarus. Later he sold out his interests to engage in farming in Exeter. From there he went to Dayton, where he again entered into merchandising business. After three or four years he came to Monroe and shortly afterwards was appointed county clerk to fill a vacancy. In 1868 he was elected Register of Deeds and was re-elected in 1860. In 1868 he was elected clerk of the town board of Monroe and in the winter of 1863-64 he was appointed recording clerk and subsequently assistant clerk of the senate at Madison. In 1884 he was elected county clerk to which office he was elected four times, serving nearly ten consecutive years in office. He held a number of minor offices and was chairman of the building committee for the construction of the new court house. Mr. Tschudy was also in business in Monroe for a long term of years. In 1872 he was in partnership with **C. R. Schneider**, the shoe business of **John McNamore** and **Kinsley** was purchased and in 1876 he became sole proprietor. He continued the business alone till 1885 when **J. J. Tschudy, Jr.**, became his successor. He then retired from active business life. He was married twice. By the wife to whom he was married in 1848 nine children survive. She died 11 years ago. His second wife died October 29, 1896. In New Glarus and Monroe, he was one of the founders of the German Church congregation—Reformed Evangelical Church. He assisted in the founding of St. John's Evangelical Church in this city in 1862 and was president of the society from that time up to three years ago. He was a long sufferer from asthma. He was an honorable businessman and as a friend he could also be counted on. He had the reputation of being a man of good impulses and kind disposition. The funeral will be held at 1:00 Friday afternoon.

Married, **Adaline Parriott**, formerly of this city but now of Hayden, Nebraska, and **Frank Youngbauer**, of Rice Lake, Wisconsin, last evening at the home of **James P. Blaine** on West Washington St., by Rev. S. E. Hauger of Trinity Mission.

Married, at the residence of the bride in the 3rd Ward, New Year's Eve, at 6:00 by Justice of the Peace Edward Buegger, **Mrs. Catherine Beach**, nee **Dixon**, and **George W. Phillips**. It was a quiet wedding and only a few relatives were present. The ceremony was witnessed by **Mr. and Mrs. Charles Hill**. Mr. and Mrs. Phillips left this afternoon on a short visit to Orangeville.

There was a large attendance of relatives and friends. An elegant wedding dinner was served at the home of the bride. The bride and groom left on the afternoon train for a short stay in Chicago after which they will reside at Glencoe, Minnesota where Mr. O'Meara is engaged in business.

Captain Charles B. Treat, son of **Mr. and Mrs. J. B. Treat** of this city was recently appointed assistant to Major General Ludlow, Governor General of the city of Havana, to enter upon his duties this week. Concerning Captain Treat, a paper at Savannah, Georgia says:

"Captain Charles G. Treat, Assistant Adjutant General, U.S.V. (1st Lt., 5th U.S. Artillery), lately in New York, is due in Havana next week for duty on the staff of Major General Ludlow. Captain Treat is a valuable staff officer having a wide experience. He was for some years A.D.C. to General Howard and lately on muster duty with General Randolph."

Carl Ruegg, better known among the members of Company H as "Coxey", who served with the company at Jacksonville, Florida and after being discharged left for San Antonio, Texas where he enlisted in Company C of the U.S. Infantry, and went to the Philippines, is reported to have been killed, having been shot in an engagement. Parties near Brodhead by whom he was employed received notice of his death.

Fred Grumpler of Adams died yesterday at the age of 52(?) years. The funeral will be held Thursday from St. John's Evangelical Church. He leaves a wife and grown up children.

Jacob Bollinger, **John Abbnehl**(?) and **Jacob Wageshach** started off for Busel(?), Switzerland. They sail on the steamship La Normandie from New York January 4.

Peter Stahl, an old settler, was in the city today. He has lived in Green County since 1855.

The funeral of the late **John Rockey** of Cedarville will be held tomorrow morning at the home at 10:30 and later at the United Evangelical Church, with Rev. B. F. Lundy officiating.

The funeral of the late **John Grempler** was held at 2:00 this afternoon at St. John's Evangelical Church with Rev. Alfred Schuh officiating. Mr. Grempler's death was thought to be due to heart disease brought about by the shock caused by the death of his son **Fred Grempler, Jr.**, who died about a month ago. Mrs. Grempler is prostrated as a result of her double bereavement. Mr. Grempler was 52 years of age.

Miss Ethel Phillips, the 11 year old daughter of **Mrs. Margaret Phillips** is in a critical condition and as a result of pneumonia and other complications.

January 5, 1899

Mrs. Franklin J. Burt died at her home in Decatur Township Tuesday evening. Her death was the result of erysipelas and was a great surprise to friends in this city who were notified today. Mrs. Burt's maiden name was **Emily A. Turman** and she was a daughter of **Benjamin Turman** who came to Green County from Indiana in the Fall of 1847 and moved to Missouri in 1867. Mrs. Burt was born in Sullivan County, Indiana in November of 1826 and had the advantage of a good education. Her father being in affluent circumstances he was able to give his family opportunities. She came to Green County with her father in the Fall of 1847 and taught school for three years being among the early teachers of the county. She was a lady of more than ordinary culture and was well known by the early settlers. A husband to whom she was married in 1850 and two sons, **John A.**, and **Frank H.**, survive.

Clara Reynolds, only 8 years old, came all the way from the Black Hills to make her home with her uncle, **Joseph Reynolds** of Franklin. Although she is young and small to travel that distance alone, she is very bright and perhaps made the trip better than an older child. She arrived on the Milwaukee Road yesterday and sewn on the breast of her winter coat was a card which read: "Joseph Reynolds, Monroe, Green County, Wisconsin". She was sent in care of **W. J. Mitchell**, the hack driver who saw that she came into the care of her uncle. He had never seen her before. While he has not adopted here, he says he will care for her at his home as long as she cares to stay. Her mother died last March, leaving the little girl and two older boys. Her father, **T. T. Reynolds**, works in the mines at Deadwood City, Black Hills and being unable to have a comfortable home for her for the present, his brother willingly consented to have her sent to him to be cared for. She is well satisfied with the change and will doubtless become a great favorite in her new home. She started on the trip last Thursday and arrived safely after nearly a week's travel.

Aren Fessenden and **Casper Bloom** from Monticello, young men who left there about two weeks ago with the intention of enlisting in the regular army, are not at St. Louis, having enlisted with the 12th U.S. Infantry for the period of three years. The boys will soon start for the Philippines.

Charles Rolph, one of the oldest settlers in the town of New Glarus, died Sunday evening. The funeral was held at Monticello today.

Mrs. Barbara Schlittler, wife of **Jacob Schlittler, Sr.**, died at Monticello Sunday. A short time ago, she fell and fractured her hip bone. She was born in the Canton of Glarus, Switzerland on July 14, 1848, and was married to Jacob Schlittler on May 20, 1863. They came to America in 1867 and settled on a farm in Washington Township. A husband and four children survive. The funeral was held today from the German Reformed Church.

Charles E. Ingleby, a former member of Company E, Beloit, aged 22, died of acute melancholia with delirium. He was at Jacksonville, Florida and returned with the 1st Regiment in September.

Mr. and Mrs. Edward Perimand and three children of Humphrey, Nebraska, arrived this evening to attend the funeral of **J. J. Tschudy**. Mrs. Perimand is a daughter of Mr. Tschudy.

Otto(?) Orto(?) Tschudy of Milwaukee is in the city to attend the funeral of his father.

Peter Tschudy, oldest brother of the late **J. Jacob Tschudy**, is in the city from South Dakota to pay his last respects to his departed brother.

Mr. and Mrs. Frankfurter of Toledo, Illinois, visited relatives here and left this afternoon for Orangeville to make a few days visit there. Mrs. Frankfurter's mother is **Mrs. George Baltzer** of this village and she accompanied them to visit in Orangeville.

The funeral of the late **J. Jacob Tschudy**, Sr., will be held Friday afternoon at 1:00 pm from the home and at 1:30 from St. John's Evangelical Church.

Mr. Zweifel is well established in the photograph business in this city whose interests here will receive undivided attention from now on.

January 9, 1899

Major Charles G. Treat is the new military title that has come to Governor General Ludlow's assistant at Havana. The promotion was made by the War Department today. Major Treat, then Captain, arrived at Santiago the day before the battle, with General Randolph, he being the general's first aide with the title of Adjutant General. He was the first to land and immediately reported to General Shafer and was given charge of placing the artillery guns. Four guns were in position when the battle started and during the progress of the fight he remained at the front to receive and disburse orders this being in the line of duty. The first day he was at Santiago he was in the saddle fifteen hours and he was in the midst of the fight the next day. He was removed with the army to Montauk Point in August. Afterwards he remained in New York as mustering officer under General Randolph until he was called to the city of Havana by Governor General Ludlow as his aide.

Mr. and Mrs. J. M. Newman of Cheyenne, Wyoming are visiting relatives in the city. Mr. Newman is the son of **J. J. Newman** of Juda.

Thomas Jones left for Chicago this afternoon. He will remain there two weeks for the purpose of having an operation.

Mrs. Fred Blumer received a telegram from her son **Christ Zweifel** informing her of the death of their child at Elroy, Minnesota and also stating that the remains would arrive here this evening for burial in the Zweifel lot in Greenwood Cemetery.

January 12, 1899

Louis Chandler, a shoe maker who conducted a cobbler shop in Albany, died suddenly Tuesday. He was at his place of business feeling unwell and had a doctor called. Although the doctor told him it was nothing serious, he said he was going to die. Soon after the doctor left him and he was dead. On account of the mysterious nature of the case Coroner R. C. Whitcomb of this city was notified by telephone to hold an inquest. He being unable to attend to the matter he deputized Justice E. E. Atherton of Albany to act in his place and an inquest was no doubt held today. The deceased was about 45 years of age and had a family.

Michael McCarthy who resided on a farm four miles southeast of the city, died at noon Tuesday. The deceased was 84 years of age and had been in feeble health for some years past. For the past eight months he had the constant care of a nurse. His death was the result of kidney trouble combined with the infirmities of old age. He was a native of Ireland and came to America, landing in Buffalo, New York and came to Janesville in 1853. For the past 35 years he has been a resident of Green County. For a number of years he has been unable to do manual labor of any kind. He leaves a widow and seven children four sons and three daughters: **Mrs. M. Hollran** of Decatur, Iowa; **Mrs. A. D. Murphy** of Monticello; **Mrs. Spencer H. Phelps** of Janesville; **John** of Monroe; and **Michael, William, and Charles H.** of Janesville. Mr. McCarthy was an honorable citizen and had many friends. His funeral will be held Friday morning at 10:00 from St. Victor's Church in this city.

The remains of **Howard Zweifel**, little son of **Mr. and Mrs. Christ Zweifel**, who died at Elroy, Minnesota on Sunday last were brought to this city on Tuesday, accompanied by the father and mother and two other children and **Mr. and Mrs. John Zweifel** of Monticello. The funeral was held here at the home of Mrs. Zweifel's mother, **Mrs. F. Blumer** on Tuesday at 2:00. Rev. Schuh officiated and the interment was at Greenwood Cemetery. The child was two years old and died of la grippe.

Birth, to **Mr. and Mrs. Charles H. Dietz**, at Madison on Wednesday, Jan. 4, a daughter.

Austin Afflerburgh of Davis, Illinois and **Miss Maude Artley** of Juda were married at 10:00 yesterday by Justice Edward Ruegger. The groom is a painter and paper hanger at Davis and is quite well known in this city. The happy couple left for Freeport and will soon go to Davis where he will continue to work at his trade.

January 16, 1899

The remains of **Fred Wettengel** who but a short time ago bid his wife and family goodbye only to be brought back ready for the grave, arrived from Glidden, Wisconsin this morning. His son, **Fred**, who made a hurried trip to the village in the north part of the state, soon after he heard of his father's death, arrived in charge of the remains. A committee from the Forest City Lodge A.C.U.W.U. of which the deceased was a member, was at the depot to receive the remains and take them to the home where a deeply grieved wife was almost prostrated as she awaited the sad home coming. The two sons, **Charles** and **Harry**, were at the depot. The funeral will be held from the house at 2:00 tomorrow afternoon and will be under the auspices of the Workmen. Mr. Wettengel arrived at Glidden, Wisconsin at 11:00 Friday night. He reached the hotel all out of breath but after a short time he recovered and registered and went to bed. During the night he was heard to call for help and he died soon after a doctor arrived. He seemed to be wild with pain and nothing could be done to relieve him. It was pronounced that death was due to heart failure.

Dewey Deal, little son of **Mr. and Mrs. Newman** of the 2nd Ward, died Sunday after an illness of three weeks. He was born May 9, 1898 and was named after the great naval hero at Manilla. The funeral will be held here tomorrow at 10:00 and the burial will be in the Hawthorn Cemetery in Clarno. The service will be held in the church.

Mrs. John Knight, an old resident of Jordan, died at her house in the 1st Ward last night after a long and severe illness. A highly respected family of grown up children survive her.

A telegram was received here Saturday morning from Glidden, Wisconsin, announcing the sudden death at that place of **Fred Wettengel** of this city. A later telegram from Dr. W. G. Low said that death was probably due to heart failure. Instructions have been made for the remains to be shipped here. He had left last Friday morning on his regular trip and was in good health. He represented Hefter, Livingston and Company Wholesale Chicago Clothing Merchants, on the road. He was born in New York City Oct. 3, 1848. He was married to the wife who survives him at Sterling, Illinois on November 18(?), 1869. Three sons, **Fred**, **Charles** and **Harry** also are left to mourn. Mr. Wettengel was formerly engaged in the clothing business in Monroe but for the past 13 years he has been traveling for a Chicago boss.

Mr. A. Woodle of Sylvester is very sick with little hope for recovery.

P. S. Patterson, who has been visiting his parents **Mr. and Mrs. Stephen Patterson**, started back to his home in Strand, North Dakota, today.

January 23, 1899

Death's call at 6:15 pm Friday released **Jacob Steinman**, the well known contractor, from painful suffering after a long and weary illness. For a large part of four months, the period covered by his illness, he had suffered the most violent and severe pain and the extent of his daily torment was beyond the realization of those about him. Nearly 17 weeks ago he came home complaining that he could not breathe but he continued at his work until he had a failing and since that time has remained home. One ailment came to be followed by another which revealed a lowered constitution and gradual decline. Dropsy came later and greatly hastened the end. Up to the time of his fatal illness, he had never seen a sick day and would not consent to be helpless as he had the vitality to do for himself. He was a native of Switzerland, born in Zurich Canton of Switzerland on Dec. 20, 1839. Early in youth he began the carpenter trade and he finally directed his attention towards building. In 1854 he left Switzerland for America and arrived in

New York in January of that year. In 1855 during Christmas week he was married in New York to the wife who now survives him. After six years in New York they came to Wisconsin and located in Monroe. He then started a long career as contractor and builder. The marks of his activities in life are many. Since he came to Monroe, contractors and builders were scarce and he labored hard and its effects brought ruin to his once vigorous constitution. Competition came later but his reputation had been made and many jobs continued to come to him. He was an honest, skilled and thorough workman and he was never known to fail in living up to the letter of his contract. A wife and four children, three sons and one daughter, survive him. They are: **Mrs. Emma Enfield, Edwin and Jacob** of this city and **Gus** of Battle City, Montana. The funeral was held on Sunday afternoon at St. John's Evangelical Church. Rev. Paul A. Schuh officiated. As the hearse that contained his mortal remains passed St. Victor's Church the bell was tolled as a mark of honor to him who in life saw to the building of its walls.

On Wednesday, Jan. 18, at the residence of the bride's parents near Clarno, **Miss Alta E. Albright** was married to **August C. Rumer**. They were married at noon by Rev. H. C. Blusser of Orangeville and were attended by **Miss Ollie (A - - - -)** as maid of honor and **Clayton Miller** as best man. Immediately after the ceremony there was a wedding dinner. About 30 guests were present. Mr. and Mrs. Rumer left the same evening for their future home in Cadiz, which had been already furnished for their occupancy.

Wordin Whitfield, who was in the city on a visit to his cousin, **W. Allen Drake**, has returned to his home at Madison.

Mr. and Mrs. Lawrence Horan left for their home at Algona, In., Thursday afternoon. Mrs. Horan came here to visit her parents, **Mr. and Mrs. John Clemmer** but she was taken sick shortly after her arrival. While she has been improving, she cannot be moved without being carried. Mr. Clemmer went so far as Janesville with them to help them in making the change of cars.

Conductor George W. Farnum has returned to his run on the Illinois Central having left the sick bed of his brother, **Joe Farnum** in Milwaukee on Friday. He reports his brother has improved. He is a conductor on the Milwaukee Road.

Mr. and Mrs. George Emerick are dangerously ill at their home in Albany. Three other members of the family are also indisposed.

Mrs. Viola Searles, nee **Davis**, formerly of Juda, died at Rockford. The remains arrived at Juda Saturday evening for burial.

Mrs. Ed Thurber of Milwaukee is here on a visit to her parents **Mr. and Mrs. H. W. Niles**.

Samuel Weismuller, an old soldier, who resides in the south part of town, is very sick.

The funeral of **Jacob Luchsinger** took place at New Glarus Saturday and a great many were present from this city. Mr. Luchsinger was born in Glarus, Switzerland in 1832(?) and came to this country in 1837(?). He leaves a wife and two sons. He served in the war and was a good soldier. His death followed an illness of 12 weeks.

Oakley: **John Zimmerman** has purchased the **James Davis** property in Oakley.

Cadiz: **Neal(?) Rinehart** arrived home last Wednesday from Carthage, Missouri, where he was visiting his parents, **Mr. and Mrs. Albert Rinehart**.

February 2, 1899

Lemuel Taylor, one of the first settlers of Jordan, died yesterday after a week's illness from pneumonia. The funeral will be tomorrow at 1:00. Mr. Taylor was born in New York on March 26, 1828(?). Later, the family moved to Oakland County, Michigan where he resided until 1843(?), when he removed to Janesville. During the 1850's he came to Green County. In Michigan, he learned the trade of millwright and he built the first saw mill to be found in this section on Skinner's Creek, which is no longer large enough to run a mill. He had considerable land that he rented out and for a number of years he has led a retired life. He invented several useful devices and devoted much time to them. He was a man of strong intelligence and moral character and his influence was always directed towards the right. He was married Nov. 28, 1859 to **Mary E. Stevens** of Franklin Co., Maine, who with five children, four daughters and one son, survive him. Mr. Taylor was a brother to **Mrs. E. R. Copeland** of this city.

John Andrews, an old citizen of Argyle, died Tuesday. The funeral was held today.

A telegram arrived here today announcing the death at 7:30 this morning of a baby boy born to **Mr. and Mrs. Henry Skilling** at Mineral Point six weeks ago. The child was sick but a few days.

February 2, 1899

Mr. and Mrs. George H. Liddle keenly mourn the loss of their little daughter, aged 8 months, death having occurred at 10:00 this morning. The baby had been sick for a month and was their only child. The remains will be taken to East Dubuque, the former home of the parents, for burial, tomorrow.

Col. Lyman Kingman died at his residence on the Green and Rock County line Tuesday, aged nearly 93(?) 98(?) years. He was a native of New York State, but came to Wisconsin when a young man. He was one of the earliest settlers in that vicinity, coming to the farm which has since been his home before Brodhead was laid out. He built on his own premises for the benefit of his own children the first school house used by the settlers in Brodhead.

Edward Barrington is the last member of Company H of the 1st Wisconsin Regiment in the volunteer service to return home. He came Tuesday. Since coming from Jacksonville, Florida with the last of the sick of the 1st Regiment, he has been cared for at Emery Hospital, Milwaukee. He was taken with typhoid fever on Sept. 5 and in his sickness he struggled bravely against great odds. He was among the youngest members of the company.

Franklin: **Mrs. B. Chenowith** is critically ill. She is suffering from bronchial pneumonia.**Marcus Wheeler** of Windsor, Dane Co., father of **Ella Weaver Wilcox**, died Tuesday. He was 90 years of age and had been in poor health for a long time.Sunday afternoon **Evan Kittelson** and his wife **Aasta** aged respectively 88 and 87 were buried in the same grave in the cemetery of the Norwegian Church three miles north of Albany.

Juda: The funeral of **Mrs. Viola Searls** was held in Juda Monday. Her death occurred Friday of last week at her home in Beloit.

Albany: **Mr. Hudson** received a telegram Saturday informing him of the death of his brother-in-law **Mr. Frazee** of Emmitsburg, Iowa. The body arrived in Brodhead Tuesday and the burial was in the church cemetery.

Henry Legler and **Mell Legler** of Valley Falls, Kansas are at New Glarus on a visit to their father **George Legler** who has been in poor health this winter. They are brothers of **F. E. Legler** of this city.

Mrs. Dewey Gardner died at Brodhead, aged 92(?). She was a remarkable woman for her age. To the last, she had control of her faculties. On December 9, her friends surprised her and helped to celebrate her birthday. She (*illegible words*) **Warren Gardner** of the Green County Board of Supervisors.

The funeral of the late **Mrs. Ruli(?) Rub(?)** of Jefferson Township was held from St. John's Evangelical Church at 2:00 this afternoon.

John Grinnell of this city has just learned of the death of his brother **Amos(?) L. Grinnell** which occurred at the residence of Mr. and Mrs. R. (*illegible*) in Vancouver, Washington on Jan. 5. February 9, 1899

The soul of **W. W. Wright** took its flight on high at 6:15 this morning at his home at the corner of Payne and Lybrand St in the 1st Ward. It was the end of a sickness of two months duration. The end was not unexpected as life had been lingering in the dark shadows for several days and the members of the family were about as he closed his eyes in death's long sleep. He had been ailing for two years but previous to that he had been in the best of health. The death was caused by cancer of the liver. The deceased was 82 years of age being born in Vermont Aug. 8, 1816. He left Vermont before he was of age and went to Ohio where he was married in 1846. By occupation he was a carpenter and joiner and he plied his trade so diligently he was able to engage in the mercantile business having a store in Salem, Ohio. After being robbed of every dollar he possessed by a clerk, he came to Monroe in 1856. He found a job clerking in abstract work. He also went to work in the office of the register of deeds and in 1857 he moved his family here. Later he became owner of the abstracts he worked on, the work being almost all his own. At the beginning of the war he was elected to the office of clerk of the circuit court and he continued in this office for 14 years. He moved into the office which he occupied until the time of his death on Jan. 1, 1878(?) 1873(?). He was in the same location 35 years. He engaged in the insurance business for a time when it was new and before it became known as a profession in this section. He was a pioneer in the abstract and insurance business and he called his office the Pioneer Agency. For a time in the abstract business, **J. J. Tschudy** was his partner. Mr. Tschudy sold his interest to **Sam Chandlis** who sold to **Wm. Wright**. For ten years following father and son conducted the business. A few years ago, Mr. Wright made a transfer of the insurance business to his son and continued the abstract business alone. Mr. Wright had the distinction of being the first mayor of the city of Monroe serving two terms after the city was incorporated. He was master of Lodge 31 A.F. & A.M. It was his wish that he be given a Masonic burial. He was an honest, upright citizen who was never found at a difference with his fellow citizens. A wife, who was a faithful life companion and

three children survive him: **Mrs.(?) J. W. Edelman**, **Mrs. A. E. Reed** and a son **William M. Wright**. He has two brothers, one resides at Akron, Ohio and another one in Vermont. The funeral will be held Sunday afternoon at 2:00 from his late home.

The couple were attended by **Miss Daisy Ames** and **Will R. Brinks**. Mr. Jordan is a farmer and he and his bride intend move to a farm in Stephenson County, Illinois.

Nels Berg, 43, night watchman at Fairbanks, Morse and Company's plant at Beloit, was drowned by falling into a tank of water in the pump testing department of the shops. The tank opening on a level with the floor, he had fallen in and had a lantern in his hand. In the summer time Mr. Berg ran a steamboat on the river.

Pte. Giser of Company C, 4th Wisconsin Volunteers, stopped off here Friday to visit before returning to his home in Platteville. He is a son of **Joe Giser** who farmed near Round Grove.

Mr. and Mrs. O. R. Olson left Friday afternoon for Jordan and decided they will take possession of a farm in the township of York that was purchased recently by Mr. Olson.

Christ Grabow of Clarno died Saturday afternoon at 4:00 after having the grippe for three days. He was a native of Germany and his age was 81 years, 3 months. The funeral will be held tomorrow morning at 10:30 from the East Clarno Church.

Buckskin: **James Padden** who has been in Iowa for the past five years is making a visit to his sister **Mrs. Jas. Keegan**.

William Henn is receiving a visit from his cousin **Phillip Demmel** of Pittsburg, Pennsylvania.

Frank L. Hodges who will soon add "doctor" to his name, is married. He was married in Chicago Monday, Feb. 27 to **Aneltsia Marguerita Leyden**, 22, of Kalamazoo, Michigan. The groom is the son of **Mr. and Mrs. W. W. Hodges**. Mr. and Mrs. Hodges left this morning for Chicago and will spend Sunday with their son and his bride and Mrs. Hodges's sister **Mrs. Ed S. Ball** of Missouri as well as Mrs. Hodge's mother **Mrs. Martin** who will also be there. The groom is a graduate of the University of Wisconsin and now is at Rush Medical College in Chicago and will soon get his degree.

Nicholas Cornelius, Monroe's pioneer citizen, was 84 Friday. He passed the day with his wife at home on West Washington Street. Mr. Cornelius can look back upon the past of every inhabitant of Green County during the early days when he first came here as he is the sole survivor of that little band of sturdy pioneers. He came to the county in 1834 and it was a long time after that before he saw a white man as there were but two families in the entire county. There were a number of empty cabins and forts that had been deserted during the Indian War a short time before. He remembers the time 300 Indians were camped for 3 weeks a short distance from where he now lives and at that time he thought nothing of it. Wild deer were running out of the grove which has long since disappeared and gave place to the public square that now marks the business center of the city. Galena was the nearest trading point and he followed a narrow foot path and waded the Pecatonia River from here to Galena and back as it was necessary. In those days, no one ever thought of sending for a doctor and mandrake root was taken for almost every illness. In his 84th year, Mr. Cornelius is wonderfully active and can be seen uptown almost every day. The burden of years has not weighed heavily on him and he is very healthy. The loss of an eye 15 years ago by acute inflammation has somewhat affected his eyesight but otherwise he is hale and hearty.

Mrs. Anna Krise and her attorney A. S. Douglas have made an appeal to Judge John R. Bennett in the Rock County Court Friday for a decree of divorce from her husband **James M. Krise** also of this city. Complaint was cruel and inhuman treatment. There was no appearance of Krise himself to contest the case. Krise is a carpenter. Judge Bennett granted her application and the plaintiff paid her own costs.

March 9, 1899

In the county grave yard at Cadiz one may read the inscription "Friends for many years" on a modest tombstone. On the north side of it are the names "Van Sant" and "Irion". There is an oaken leaf cut deep at the top of the tombstone and this more explains the inscription below:

"**Henson, Iroion**, 18—to 1894; **Abner Van Sant** 1786-1846"

The granite stone rests upon two millstones which share the date of (*illegible*).

The rather unusual inscription and the peculiar foundation stones of the monument are enough to arouse the curiosity of an ordinary person. **Isaac T. Williams**, a pioneer of 73 years is an interesting type of early pioneer, who lives about a mile and a half from the village of Cadiz. He tells a story of the men who were friends for many years. Abner Van Sant moved to Clarno Prairie, Wisconsin, in 1838. His family came from the east. In 1835 he erected the first grist mill in what is now Green County and which was then a part of Iowa County. In 1843 he erected the saw mill at the village of Cadiz. Van Sant was a native of Pennsylvania. He was exceedingly fond of adventure. In 18?? he came west to St. Louis expecting to join Lewis and Clark's exploration company that traversed the great Northwest Territory. He was too late, however, as the adventure party had already left. He spent a number of years in the Missouri Territory. He was prominent in politics in the new country. In 1820 he was a candidate for member of the

delegation that was to form the new constitution of Missouri. Some years later, Van Sant journeyed north from Mound City, Illinois finally reaching southern Wisconsin where he lived a useful life up until death cut him down.

Henson Irion was a native of Ohio. He was a descendent of French Huguenots and inherited a spirit of travel which early urged him westward. He came to Naples, Illinois at an early day and then proceeded to the east fork of the Fever River and Galena where he engaged in mining. When the war broke out he fought six months against Black Hawk, receiving \$86 pay. He attended the reunion of the veterans at Lena in the years previous to his death. In 1837 he went to Green County where he erected a mill on Honey Creek. It was afterwards operated by **Mr. Bowers**, now of Orangeville. In 1845 he bought the corn and saw mills at Browntown.

Irion was single all his life. He was a very quiet man, possessing a good education and a strong natural sense. Van Sant was married and had two children but as none of his friends were in the section he was buried in the Cadiz Cemetery and later his old friend Irion was placed beside him. Of **Isaac T. Williams**, their mutual friend, there was extracted a promise that he would bury them together and mark the grave as has been done. The inscription was dictated by Mr. Irion. The mill stones which formed the base of the monument were the first used in Green County in making flour. Strangely enough at one time in their lives both these pioneers used the same mill stones which are now over their grave tomb. The stones were cut from a solid bolder. They are of the red or lost rock specie and being nearly as hard as flint it must have been very hard to shape them. Mr. Irion's theological views has undergone quite a liberal strain. This is what he said to Mr. William's one day: "If you survive, bury me by the side of Abner Van Sant and if there is a day of resurrection, I wish Abner Van Sant to be the first man I take by the hand."

March 9, 1899

Jacob Hoosier, the Platteville pioneer, is dead. He died Saturday evening at his home one mile south of Platteville. He was 93 years of age and up to the time of his death lived on the same piece of land that he entered from the government in 1825. He was a veteran of the Black Hawk War and was wounded at the block house fort three miles south of Platteville. He leaves a wife and four children. His death removed one of the principal witnesses in the Hoosier poisoning case now pending in the circuit court in which his oldest son and grandson are accused of trying to kill the balance of the family something over a year ago.

Rev. Charles M. Varney was called to Jefferson today to conduct the funeral of **O. S. Brandon**, which was held there today. Mr. Brandon has been a promising citizen of Jefferson for many years.

Clarno: The funeral of the late **Christ Grabow** was held at the M.E. Church on Tuesday. He was the father of **Carl Grabow** and was 81. e leaves a wife and one son and one daughter. He was sick only two days. Rev. P. A. Schuh of Monroe officiated.

Mrs. Jones of Escanaba, Michigan arrived in the city Tuesday on a visit to her sister **Mrs. Will Hawthorn**.

Albany: **Mrs. Seth Hewitt** of S.D. who has been in Albany for several weeks taking care of her mother **Mrs. Bell**, returned home last week.

Married, **Miss Fannie Kubli** and **Fred Benkert**. They were married quietly at St. John's parsonage on Wednesday afternoon by Rev. Paul A. Schuh. None of the friends and relatives were present. The couple at once left for the Eley farm five miles southeast of the city where a nicely prepared home awaits them. The bride is the daughter of **Rudolph**

Kubli who lives on a farm east of town and the groom has managed and worked the Eley farm for a number of years.

Sheriff Gardner and Under Sheriff N.S. Durst left for Mendota this Friday having in charge **Samuel Beller** who was judged insane by Judge J. M. Becker upon the recommendation of Drs. Loofbonrow and Moyer who made the exam. Beller is a cheese maker in the township of Washington. He has a wife and two children. He was violently insane and dangerous.

March 23, 1899

She retired Wednesday night as well as usual and a heart attack that came while she was in bed was the cause of her death. She was a person who was never well and was always troubled by nervousness. She was very quiet and found more real comfort at home than in a large group. Her death was a shock to the family. The funeral probably will be Sunday from the home.

Mrs. Ed Thorpe of Clarno is visiting in this city at the home of her parents **Mr. and Mrs. Thomas Evans**.

Miss Josephine Weathersby of Shullsburg and **Edward Russell** of Dunbarton were married at Shullsburg Wednesday at noon. The bride is the sister of **Mrs. C. S. Dodge** of this city and is an elocutionist who has been heard here.

Mrs. Elmira Northcraft died at the home of her daughter **Mrs. A. Davis** in Spring Grove on Thursday night. She was a native of Hampshire County, Va. She came to Wisconsin with her husband the late **Samuel Northcraft** in 1845. They made the trip in a wagon and were 27 days on the way. In 1847 Mr. Northcraft settled on Section 28 which remains the family home. The funeral was held from the home today and the burial was in the Dawson Cemetery.

The body of **Charles Goeltz** the farm hand who hung himself was buried Monday. Over three weeks have passed since his death and the body has been at Shriner Brothers Funeral parlor all this time. All efforts to locate the dead man's relatives have been fruitless. He was buried in the cemetery at the county farm.

A telegram that was received here at 8:00 Friday brought the announcement of the death of **John Greenwald** at Hammond, Louisiana. The message was a sad one and was unexpected. The family here knew of his illness but thought he was improving. The remains will be brought here for burial. It was early in December, 1894 that he left home to move to the South in the hope that the change in climate would benefit his failing health. A week after arriving there he went to work at his trade, that of a tinsmith, and continued his work until three months ago. Since going there, he was home on a visit and was feeling well. His only sickness came 12 weeks ago when he was taken down with fever and lung trouble and when it was thought that the worst was over he was called by the summons of death. He was born in this city on Sept. 19, 1868 the son of **Mrs. Catharine Greenwald** who still resides here. On May 20, 1890 he married **Ida Lohr**, daughter of **Mrs. S. Lohr** of this city and the union that is now broken was a happy one. He leaves besides his wife a mother and brothers.
