We learn from a gentleman of Monticello that about 10:00 on Monday last a young man by the name of **Charles Gilson** attempted suicide by cutting his throat with a razor. Exchanging Ohio for Wisconsin, he arrived with his family in June of that year, and located in this village upon a tract of land he had purchased the year previous. While residing in Newark, Ohio, he was converted through the efforts of (*illegible word*) Uriah Heath and in the year 1844 joined the M.E. Church of that place. During a seven year residence in this town, Mr. Putnam won the confidence and greatly endeared himself to the hearts of our citizens and at the time of his death held the position of chairman of the board of supervisors for the town. Kind in disposition and unobtrusive in manner—of inflexible integrity coupled with a high sense of honor, he enjoyed the esteem of all. Possessed of a liberal competence and (*illegible word*) by a number of highly respected connections, he was cut down in the full tide of manly strength and usefulness.
