We have been favored by **Mr. J. Kelly** with the following letter from **George Kuykendall** who left this town for Oregon territory about one year ago:

Milwaukee, Oregon Territory, Jan. 16, 1853

Dear Sir:

We have finally arrived in Oregon safely though we had a hard time off the last end of our journey owing to so large an emigration and our being rather late; grass in places is scarce and considerable sickness on the way. Among the emigrants Ping and his wife both got down sick and John K. was sick; but of a common season with proper care I think, there is not much danger of sickness. We have had an unusual winter here, one pretty good snow and a great deal of rain and provisions are quite high. Wages are rather low at present but we do not expect that state of things to last long. I have been at work at \$4 per day but when spring comes we expect wages will be up. This part of the country is very heavily timbered and more adapted to lumber then farming. The part we have stopped in we do not expect to remain in. We have stopped in a town situated on the Willimeta River called Milwaukee, the largest and best town in Oregon where shipping comes in and takes off to California all lumber and surplus produce.
