His disease was cancer of that portion of the bowels which lie directly to the left of the right hip. This had been progressing slowly but insidiously for some years finally it completely obliterated the cavity of the intestines at the above named point and consequently resulted in his death. J. M. # March 14, 1860

Died, in Clarno, on the 28th December, **Adam Starr**, 76 years, 10 months, 8 days. Father Starr was born in North Carolina and emigrated to Prebble Co., Ohio—from there to Vermillion Co., IL. In the year 1837 he came to Wisconsin. In the death of this good man the children have lost an affectionate parent, the children a loved member and society a worthy citizen.

Died, at Richland Center, March 6, **Rosannah**, aged three years, six months; on March 11, **Robert Morris**, three years, sixteen days, **daughter and son of D. B.(?)** and **Sarah L. Priest**. (transcriber's note, something not quite right about the ages of the children.)

Married, on the 18th inst., at Hills Hotel, by L. Rote, Esq., David Coleman to Mary L. Hill, both of this village.

Married, by J. W. Shuey, Esq., at the residence of the bride's father, in Monroe, **Mathias Sibley**(?) of Orangeville, Id., and **Anna M. Fry**, of Monroe, on the evening of the 10th March last.

# April 4, 1860

Died, on March 26 at Beloit, Ida J., daughter of J. J. and M. J. Mosher, four years, four months.

Died, at Monroe on the 30th March, Charles S., son of T. H. and Martha Eaton, aged four years, one month and fourteen days.

Ho! For California! F. H. West and Wm. O. Carpenter of this place will, on Monday next, start with a train for California. They take with them twenty young men from this vicinity, five wagons and 65 of the finest blood horses they could procure in this county. The passengers are Robert and John Millman, Charles King, C. D. King, W. W. Truax, M. J. Whitesett, Newcomb Williams, John Dunn, Martin Austin, Alex Brunson, Moses Mann, Edw. McKendall, Solomon Hoffman, Frank Evans, Stephen Stephenson, Edmund Edmundson, Peter Peterson, Thomas Corning, Gilbert Anderson. Messrs. West and Carpenter will go via Dubuque, Omaha and Salt Lake City. On the same day Messrs. Willard Payne and E. N. Shelton start a train of eight or ten horses accompanied by three or four men for California. On the same day also Messrs. T. Stevenson, Clark Godfrey, and Jesse Robinson leave Monroe for Pike's Peak.

# May 16, 1860

Just as we go to press we are informed by **Mr. Bridge** of Jefferson that this (Tuesday) morning he discovered two miles south of this village a young man named **Asher Grant** of Clarno crushed in a horrible manner by a tree that had fallen upon him. Life was extinct. He was twenty feet from the stump and appeared to be running from it when the tree fell upon him.

# June 6, 1860

Married, at Harmony Springs, Arkansas, may 4, by J. E. Spencer, pastor of the Harmonial Theocratic *(illegible word)* Church, **Henry E. Dewey** and **Sarah J. Tenney**, both of this town. Miss Tenney is a **daughter of A.D. Tenney**, formerly of Clarence, this county.

**John Chandler**, formerly a resident of this village was killed in Pleasant Grove, Minnesota, 22nd inst. The following are the particulars taken from testimony given during the examination: "I live in the town of Pleasant Grove and was in **J. D. Bunce's** store on the 22nd day of May last between two and three pm. **Mr. Mills** was assisting Mr. Bunce to

post the books. Both of them were inside the counter on the west side of the store. When Mr. Chandler came in, Mr. Mills said 'here is an account against Mr. Chandler for five cents worth of fish hooks.' Instantly a conversation took place between Mr. Bunce and Mr. Chandler in regard to some work that Bunce had taken to Chandler to be done in which some other person was going to pay for. Mr. Bunce said that he told Chandler at the time he took the work to Mr. Chandler that the other person was to pay for the work. Chandler replied that Bunce did not tell him so but that this other man told him of it. Bunce then said 'you probably mean to say I lied about it.' Mr. Chandler replied 'if you persist in saying so, you lie'. Bunce said 'you had better call me a liar'. Chandler replied 'if you persist in saying so, you are a liar'. Bunce then told him to leave his store and got up from his seat, went behind Mills to the end of the counter. In going around the counter, he made a step or two forward to get a weight which was lying a short distance from the counter on some boxes. He then advanced toward Chandler with the weight in his hand. As he advanced, Chandler said 'don't you throw that weight at me'. Bunce came up to Chandler and took him by the collar with his left hand. At the same time, Chandler raised his arm to prevent it. A scuffle followed. Bunce pushed Chandler out of the store and threw the weight at him, striking him with it, giving a fatal wound on the head. From the effects of it, Chandler was dead in twelve hours.'' He leaves a wife and four children.

## June 13, 1860

On Monday evening this village was visited by a thunderstorm of more than usual violence and duration. In the early stages of the storm the lightening entered the house of **Mr. Martin**, a German citizen who resides in the western part of the village, instantly killing his wife who sat upon a chest near the window reading. It appears that Mr. Martin had left the house for the purpose of carrying home one of his neighbor's children and on his return found his wife lying on the chest, her head over the end of it—dead, yet warm. On examination it was found that the lightening had struck the closed window and entered the room through a small aperture and then into the person of **Mrs. Martin**.

#### August 29, 1860

The late **Rev. Charles Adolphus Boardman**, who recently died in this village, was born Nov. 19, 1788 in New Melford, Litchfield Co., Connecticut. He was married to **Sophia Hine** on March 7, 1811. He was induced to enter upon a course of theological study by Rev. A. Elliott of New Melford, Ct., and was ordained in February of 1813(?)1818(?) as pastor of the Congregational Church at New Pr - - en. Rev. Dr. Lyman Beecher delivered the charge to the new pastor. He continued as the successful pastor of the church for twelve years when he was called to the 3rd Church of New Haven, in April of 1830. He labored for two years and then thought it to be his duty to accept a call from the Congregational Church in Westport, where he remained four years. He then went to Youngstown, Mahoning Co., Ohio in 1838. There he labored for Christ and lived in the hearts of the people upwards of 16 years. In the year 1854, being then a widower, he removed to Monroe intending to spend the remainder of his life with a married **daughter, the wife of S. B. McEwen**. Soon after he removed to Monroe, he was prompted to preach to the small remnant of a Presbyterian Church. He preached with success for about two years when he retired from active ministry. This church at its re-organization took the form of a Congregational Church. It has flourished. Yet the attachment between himself and the congregation at Youngstown continued till his death. He spent the

whole of last winter among them and returned to Monroe about three months ago when he began to *(illegible words)* and the Master called him home. His death was peaceful, happy and glorious. E.M.

## September 26, 1860

On Saturday last, just as the exercises were closing on the fairgrounds, **Mrs. Peter Yost** of Clarno was knocked down and run over by a two horse wagon loaded with *(illegible word)* under circumstances that ignite the deepest indignation. Her face was severely lacerated and several ribs were broken. At present, she is lying at Hill's Hotel in a dangerous condition. The team was driven by a reckless fellow named **William Pabster**(?) whose carelessness driving has often been noticed in our village. He came dashing into the crowd running over Mrs. Yost just as she was about getting on the sidewalk.

A heart rending tragedy occurred at Rock Grove on Tuesday evening of last week. It appears that a German hired man in the employ of a respected widow lady had made proposals of marriage to his employer which she had rejected. The German was under the impression that she was receiving attention from another and had vowed the destruction of his rival. On Tuesday last early in the evening **Dr. Bachman** of Rock Grove, a young and esteemed physician, called on the widow lady on his way home to procure a quantity of flour for his family. The German, mistaking Dr. Bachman for his supposed rival, stationed himself at the door with a butcher knife. When the doctor came, he attacked him stabbing him several times in the breast, once through the arm and drawing the knife across his back inflicting a frightful wound from which on one side his kidney protruded through the bash. The German on finding that he had attacked the wrong man went to another doctor to come. He stated that Dr. Bachman had been attacked by six robbers and cut to pieces. The excited manner of the man lead the doctor to suspect something wrong and to disbelieve his story. He did not go until the next morning when he was sent for. The doctor still lives but the chances for his recovery are remote. He is much respected and a promising physician. He is a brother of John Bachman formerly of this place and has a wife and child residing at Rock Grove. The German was promptly arrested. Soon after, he tore up a sheet and hung himself and was found dead in his cell.

**Nehemiah Root**, who several years ago was tried for the murder of his son-in-law, **E. C. Foster** at Mt. Pleasant, in this county, was one day last week arrested for threatening the life of several citizens in Albany and lodged in the county jail. Since his confinement he has demonstrated to the satisfaction of all that he is insane and ought not to be at large. When his counsel who conducted his defense on the charge of murder secured what was equivalent to an accrual on the plea of insanity; the greater majority of our citizens did not accept the idea that he was insane. But the result proves that his counsel was correct and the majority were mistaken. We are informed that at times Root is very violent.
