April 24, 1861

A most heart rending occasion occurred on Monday evening in this village the likes of which we trust, it may never be our duty to record again. Several of the young men of this village were firing the cannon in honor of the country and of the volunteers. As they were driving home the last cartridge the gun being heated by the rapid firing, prematurely discharged while **Judd Hulbut** and **Edward Morris** had hold of the ramrod. The right hand of young Morris was completely blown off at the wrist and shivered to atoms. His face was frightfully burned and torn by the slivers of the rod. Hulbut's left arm was also blown off and his right hand burned and mutilated shockingly so that half of it has since had to be amputated and it is doubtful yet whether his remaining thumb and two fingers can be saved. The shattered arms of both of these have been amputated between the wrist and elbow.

Morris is the son of **Rev. Edward Morris** and a young man of fine promise. Hulbut is a son of **Col. L. Hurlbut** and was a foreman printer in this office and gave promise of excelling in the avocation he loved. A bright future seemed before him. Both of them are generous, impulsive young men of good habits, beloved and respected by the young people of this village and highly respected by all. The gun was blown to slivers and one of the slugs was shot through the beam, tore down a fence post and penetrated a roof in its course. **Charles Humphrey** who was thumbing the cannon, had his thumb badly torn and burned and his eyes injured by the powder though not so seriously as to affect his sight.

Our fellow townsman **Dorman Perkins**, starts in a few days for California. He takes his family with him to his permanent home.

May 1, 1861

Judd Hulbut and **Edward Morris**, who were so seriously injured last week by the discharge of the cannon, are, we are happy to state, now doing well and lively hopes are entertained for their speedy recovery from their wounds. The amputation of the mutilated arms of both young men was performed by **Dr. J. M. Ball**. Though in both cases these were difficult and delicate operations and performed in the night, immediately after the accident, they were successfully done. The remnant of Hurlbut's right hand, though much mutilated, will probably be saved so as to leave him a serviceable thumb and two first fingers. On Sabbath last **Dr. Lombard** extracted from the socket of young Morris, several splinters two of which were three quarters of an inch in length. They were slivered from the ram rod and penetrated the eye socket just above the eye ball. An incision had to be made in the eye lid to extract them. They were rough and jagged and it is a marvel that the eye escaped. The operation of extraction was exceedingly painful.

July 17, 1861

A letter from **M. Kelly, Jr.**, dated 6-21 at Utah Territory, 12 miles west of Ft. Brieger(?) and 100 miles east of Salt Lake City, brings the painful intelligence of the death of **Andrew J. Brundege** of this place. Mr. Brundege was a man of very superior abilities. He was not composed of baser metals nor cast in the common mold. With a mind peculiarly direct and clear in its purpose with analytical powers of a high order, with a tenacity and power of extraction, that was greater than ordinary. The tenacity with which he clung to life and the unflinching determination with which he contested every inch of ground with the insidious disease which had fastened upon him excited universal sympathy. When all other available help failed, and in the last stages of the disease, he undertook the forlorn hope of a trip to California affording the only prospect of relief. But it was too late.

October 9, 1861

On Saturday next, **Augustus Liessring** opens a restaurant on the east side of the square

A much lamentable occurrence took place about three miles southeast of this place on Saturday last. A young man named **Benjamin Gapen**, son of **Lewis Gapen**, Esq., of Jefferson, hung himself in a barn belonging to **Levi Deal**. The young man was a miller and for some time previous had the management of Mr. Deal's grist mill and boarded with his family; on Friday evening last when Mr. Deal and his family retired, his mill was running. On Saturday morning when breakfast was ready, Benjamin not making his appearance, a son of Mr. Deal was sent to his room to call him and found that he had been there but had left. Search was immediately made for him but he was not found until about noon when upon searching the barn he was discovered suspended from one of the rafters. An inquest was held Saturday afternoon and from the testimony adduced it appears that for some time past he had been laboring under a severe mental depression and that to some of his friends he had expressed a fear that he was "losing his mind". He was an exemplary young man and his friends deeply deplore the affliction which overthrew his reason and induced the act which terminated his life.
