# April 30, 1862

Married, at the residence of the bride's father at Clarno, by Rev. P. H. Green, **Howard Dunaway** to **Mary P.(?) Simonds**, both of Clarno.

Died, in this village at the house of her son-in-law **Thomas H. Eaton**, Esq., **Mrs. Frances Eagley**. She was born Feb. 22, 1782 in Lancaster Co., Pa. She was twice married and twice widowed. At the death of her first husband, **Peter Albert**, to whom she was married in her 18th year, and who died in 1829, the care of twelve children was thrown onto her hands. The youngest of whom was **Mrs. Eaton**, was then five years old. She laws a faithful Christian mother. She was again married in 1835 to **Jacob Eagley** with whom she lived until 1855 when she became a widow for the second time. Mrs. Eagley had a Christian parentage and was reared to the fear of God. Her death was a great example of Christian triumph. A few days ago she became satisfied that her earthly pilgrimage was about to change and the sacrament of the Lord's supper was dispensed to her at her request. The same afternoon she paid a final adieu to her children, grandchildren, calling them to her bedside and exhorting them to a faithful discharge of their several duties; shaking hands and kissing them for the last time. She left messages of love for those who were at a distance. She took an affectionate leave of the neighbors who were present at the time, speaking to them of the love of God. She lingered a few days after this event and then died in peace.

#### May 14, 1862

We have hitherto forgotten to mention the fact that **N. Root**, who some years ago shot his son-in-law **E. C. Foster** at Mt. Pleasant and who, upon trial for the offense, was acquitted on the grounds of insanity, and since that time has been confined by the order of the court, has been forwarded to the care of his son in Canada. Henry Adams, Esq., chairman of the board of county commissioners went with Mr. Root to Canada and describes the meeting between the father and son as truly affecting. Let us hope Mr. Root may pass the remaining days of his life possessing his reason.

Died, at Monroe on the 4th inst., **P. D. Nobles**, aged 86 years, 8 months and 4 days. Mr. Noble was born in Massachusetts in 1775 and emigrated to Kentucky in 1815 where he resided 26 years, removing to this town in 1841 where he continued to reside up to the time of his death. He was a quiet, inoffensive man esteemed by all who knew him. When the final summons came he appeared resigned, expressing a desire to depart and be at rest.

May 21, 1862

On Friday afternoon last near Twin Grove in the township of Jefferson, **Horace Hunt** was struck by lightening and killed. Mr. Hunt was at work in the field near a straw stack. He had a team, a hired man and two boys with him. The hired man was stunned so severely that he did not recover his consciousness until the team had gone some distance. The boys were also affected so that they were blind for a time. The electrical current struck Mr. Hunt upon the neck and passed through the body and both limbs to his heels. Only about one week ago while Mr. Hunt was taking shelter from a rain storm in horse stable covered with straw, the stable was struck by lightening and he was stunned from the effects of which he had not yet fully recovered.

Died, on the 25th May, at the 6th Division Hospital of typhoid fever, **James Hall**, 18, near Pittsburg Landing, Tennessee. Also, at the same place and of the same disease on the 30th May, **Ezra W. Post**, aged 19. Also, at the same place and of the same disease on the 26th June, **Daniel J. Youngblood**, aged 27.

The above named all enlisted at Monroe as soldiers in Captain Jackson's Company, 18th Regiment Wisconsin Volunteers and while serving in the army in Tennessee contracted the disease which caused their death. They passed safely through the battle at Pittsburg Landing (Shiloh), conducting themselves like true soldiers. They now rest where no sorrow can trouble them beneath the soil of the Tennessee Valley never again to be disturbed by battle's toil. We miss them as brothers.

## August 27, 1862

We learn that the residence of **John Mather** in Spring Grove was burned on Tuesday afternoon while all the family was at church. A neighbor discovered the fire in time to save one bed—all the furniture with the one exception was destroyed with the house. When the news reached the church a collection was taken up for their benefit and we learn that about \$200 was raised.

Many of our readers in the northeast portion of our county will remember **Franklin Hickok** who removed to California from the township of Brooklyn about a year ago after residing there for several years. Misfortune seems to have followed him ever since his arrival in the land of gold. Recently three of his children the oldest being 16 years of age, while out picking berries were brutally murdered by Indians. A California paper thus alludes to the severe trials of Mr. Hickok during one short year:

"Franklin Hickok, the father of the girls who were recently murdered near Chico in Butte County by the Indians, arrived in Sacramento at noon yesterday from the Humbolt mines. He had left his family in Butte County and crossed the mountains to Washne(?) in search of employment. Being a mill wright he received an order from John C. Fell to go to the Humbold mine region to put up a mill. On reaching this spot he learned that different arrangements had been made and that his services wound not be needed. While still unemployed he received a message from home informing him of the terrible fate of his three children. The family arrived in this state from Wisconsin about a year

ago with very limited means and very soon had a span of horses worth \$1,000 stolen from them. The father and the deceased **daughter Ida** then worked several months for the proprietor of a new flour mill in the northern part of the state who subsequently failed, they losing thereby all that was due them. The experiences of the family in California have been that of misfortune."

Our postmaster **Mr. Bartlett** on Monday received the following notice from Beloit. He immediately initiated inquiry for the friends of the little wanderers but up to the time of our going to press we have not been able to learn anything in relation to them

On Saturday morning, 25th ult., **Miss Martha Acasta Davis** of this place committed suicide by taking strychnine. A inquest was held on the body by L. Rote, Esq., J. P., at which inquest **R. B. Brownfield**, **Mrs. Elizabeth Brownfield**, **Mrs. R.J. Stephenson** and **Mrs. Ann Beattie** were examined as witnesses from whose testimony it appears that the deceased was afflicted with hypochondria and in one of her desponding moments voluntarily took poison which terminated her existence.

#### October 8, 1862

A very melancholy casualty occurred in the town of Clarno on Saturday last by which **Frank Jones**, s**on of Joseph Jones** of that place between 7 and 8 years of age came to a sudden death. The deceased was in the woods with others

for the purpose of gathering roots and while riding in a wagon was thrown out by an overhanging limb of a tree and his head falling between the wheels of a wagon and a sapling was shockingly crushed, causing death in about ten minutes.
